Proceedings against M/s East India Watch Co., the O.P. herein, have been initiated u/s 7 of the P.P. Act for adjudication of the prayer of Kolkata Port Trust (KoPT) for order of recovery of damages in respect of Kolkata Port Trust's plot being land measuring Pucca Room No. 1 msg. About 5.016 sqm. or thereabouts adjoining the northern boundary of Kolkata Port Trust's Strand Warehouse situated on the west side of Strand Road under North Port Police Station.(under Plate No. SW 102)

It is worthy to point out that Postal Service to O.P. herein was returned undelivered with the remarks of the Postal Department as "Insufficient Address".

AND WHEREAS, the report of the Process Server dated 8.11.2017 also reveals that order dated 3.11.2017 could not be hand delivered as the address of O.P. was not found.

AND WHEREAS, no reply to the show cause notice has been filed as yet.

NOW THEREFORE, in exercise of the power conferred upon me, I hereby give notice to all concerned interested in the property under schedule to file reply to the Show Cause Notice on or

before 07.02.2018 and to appear before me on 07.02.2018 at 12 noon either in person or through authorised representative (along with a letter of authority) capable of answering all material questions in respect of the property described under the Schedule below, failing which the matter will be decided exparte without any further reference.


