ORDER UNDER SUB-SECTION (1) OF SECTION 5 OF THE PUBLIC PREMISES (EVICTION OF UNAUTHORISED OCCUPANTS) ACT, 1971

WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that Shri Gaya Prosad, Quarters being No. 47&48, Block No. Q, at Taratala New Colony Mazdoor Line, P.S. Taratala, Kolkata – 700 088 is in unauthorized occupation of the Public Premises specified in the Schedule below:

#### REASONS

Taratala, Kolkata – 700 088 and all persons who may be in occupation of the said premises or any part thereof to vacate the said premises within 15 days of the date of publication of this order. In the event of refusal or failure to comply with this order Shri Gaya Prosad, Quarters being No. 47&48, Block No. Q, at Taratala New Colony Mazdoor Line, P.S. Taratala, Kolkata – 700 088 and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.
