Reference above, your offer vide no. PIE-239/ Tender/2018-19/52 dated 23-10-2018in response to our NIT No. Hyd/ 12140/821 dated 02-02-2016 has been accepted by the competent authority for "Delivery, Supply, Testing & Installation of One no. High Precision Single Frequency Portable Digital Echosounder (Make: SyQwest Inc., Model: HydroBox 'HD') with all accessories (One Laptop computer, Moxa USB to Serial Converter, Interface Software, Data I/O Cable, Power Cable, Adaptor, LAN to USB converter etc)" and subsequent Comprehensive Annual Maintenance Contract (CAMC) for Seven (7) years after free warranty period of one year as laid down in the tender at a total cost of Rs.18,95,000 (Rupees Eighteen Lakh Ninety Five Thousand Only) plus GST as applicable.

The cost of echosounder with all accessories, including installation, commission, training for 2 (two) days and warranty of one year will be in tune of Rs. 9,50,000/- (Rupees Nine Lakh Fifty Thousand Only) plus GST as applicable.

Comprehensive AMC of the instruments @ Rs. 1,35,000/- per year + GST as applicable including all expenditure, for seven years after expiry of one year free Warranty Period of one year.

- 2. The following items are to be supplied, commissioned and tested at site:

 Digital Echosounder, along with all accessories, interface software, Installation & Operator Manual,
 power cable (10ft), Data I/O cable (10ft), electronic sensor unit, Transducer 210 KHz etc
 Quantity: One (1) number
 - One Laptop Computer (HP/DELL Make) with requisite software, laptop charger etc, Moxa USB to Serial converter, Adaptor, LAN to USB converter for interfacing with digital echosounder as mentioned in list of deliverables of your offer under reference.

3. Compliance of Specifications:

The items to be supplied (as mentioned in your offer) are to be in compliance with specifications as mentioned in the NIT under reference.

4. Payment Terms:

The 90% of the payment for the supply, installation, commissioning etc. will be paid after satisfactory completion of work, on submission of bill in quadruplicate along with commissioning certificate and remaining 10 % will be paid after satisfactory completion of contract period of eight year. However 100% payment will be released after satisfactory completion of work, on submission of bill in quadruplicate along with commissioning certificate if performance bank guarantee (PBG) of remaining 10% issued from a nationalised bank having branch at Kolkata, for a period of eight years and claim period of further three month is provided along with the bill.

The payment for the Comprehensive Annual Maintenance Contract (CAMC) for seven (7) years after warranty period of one year @ Rs. 1,35,000/- per year plus service tax as applicable will be paid on half yearly basis i.e. after satisfactory completion of every six month period on prorata basis.

5. Conditions of CAMC:

The CAMC should be provided as per conditions stated in the tender document (NIT) and as agreed upon. However the following should be complied:

- Maintenance of the instruments and its operation during entire contract period.
- Maintenance / up-gradation of software as applicable, during the contract period.

6. DAP (Delivery at Place)

Please note that equipment in totality are priced in INR, DAP Kolkata with requisite insurance etc at Hydraulic Study Department, Kolkata Port Trust, 20 Garden Reach Road, Kolkata -700043, India.

- 7. You are supposed to bear all Indian corporate and personnel taxes in case of applicability as per provision of the Indian Income Tax with amendments if any thererof.
- 8. You are also requested to note that the supply and maintenance of the instruments viz the contract has to consider all relevant Indian Acts those are applicable for execution of the work in question.
- 9. Please note that you will be guided by the terms and conditions of General Conditions of Contract, Special Conditions of Contract, all other particular specification etc as referred in NIT.

10. Liquidated Damage (LD):

Please note that this is turnkey job. The work Delivery, Supply, Testing & Installation of One no. High Precision Single Frequency Portable Digital Echosounder (Make: SyQwest Inc., Model: HydroBox 'HD') with all accessories (One Laptop computer, Moxa USB to Serial Converter, Interface Software, Data I/O Cable, Power Cable, Adaptor, LAN to USB converter etc) should be completed in all respect on a turnkey basis to the satisfaction of the Engineer within Forty Five (45) days from the date of acceptance of work order. Failure to complete the work in totality within the due date will attract relevant provision of the LD clause as mentioned in Tender Document.

- 11. Seven years Comprehensive Annual Maintenance Contract (CAMC) after one year free warranty period has to be provided as per conditions of tender, failure to do so will attract relevant provision of penalty, risk purchase clause etc, as mentioned in the Tender Documents. In the CAMC period, equipment should be restored within five (5) working days after reporting of fault. In case of failure to restore the equipment within specified time, will attract imposition of penalty @ ½ % of prorata value of CAMC for the respective year for every week or part thereof, subject to a maximum of 10% of the total value of CAMC for respective year for each non-restoration of fault which would be deducted from the CAMC payment.
- 12. The Digital Echosounder with all accessories is to be warranted as per terms and conditions of NIT for a period of twelve (12) months, after the date of satisfactory acceptance.
- 13. You are required to enter into a formal agreement with KoPT within one month from the date of acknowledgement of work order, on a non-judicial stamp paper of Rs. 100 (Rupees One Hundred Only).
- 14. This may please be treated as formal Work Order and you are requested to return one set of the same duly signed and stamped in all pages of instant work order as a mark of acceptance.
