In the event of your refusal or failure to pay the damages within the said period or in the manner aforesaid, the amount will be recovered as an arrear of land revenue by Collector.

FINAL ORDER

The instant proceedings No. 1389/D of 2013 arises out of the application bearing No. Lnd.6/74/19/420 dated 15.05.2019 filed by the Kolkata Port Trust (KoPT), the applicant herein, praying for an order of recovery of compensation/damages and other charges etc. along with accrued interest in respect of the public premises as defined in the Schedule of said application, against M/S Indian Export Enterprise, the O.P herein, under relevant provisions of Public Premises (Eviction of Unauthorized Occupants) Act, 1971.

The fact of the case in a nutshell is that the O.P. came into occupation of the port property being godown space measuring 173.264sq.m.or thereabout situated on the west side of Strand Road, (under Plate No.JS-20/1) as monthly Lessee, more fully described in the 'Schedule of Property' of the KoPT's application. The allegations levelled by KoPT against the O.P is that, while in possession of Port property as monthly Lessee, the O.P has defaulted in making payment of damages/compensation and taxes and also accrued interest thereon the details of which application dated KoPT's the given in has 15.05.2019.

It is the case of KoPT that the O.P. was asked to pay damages/compensation upto 31.08.2015 as because the subject premises was taken over by KoPT on 31.08.2015.
