

The matter is taken up today for delivering Final Order. It is the case of Kolkata Port Trust(KoPT), Applicant herein that Shri. Kamala Prasad Shaw (O.P) came into occupation of the Public Premises in question being land space measuring 33.445 sqm. (comprised under occupation No. D-377/2) as a short term lessee and that O.P violated the condition of tenancy under said short term lease by way of non-payment of rental dues. It is argued that O.P. has no authority under law to occupy the Public Premises after expiry of the period as mentioned in the notice of ejectment dated 19.09.2006 as issued upon O.P. by KoPT. This Forum of Law, upon receipt of information from the Applicant and being satisfied with the inputs furnished by KoPT decided to proceed against O.P. under the relevant provisions of the P.P. Act and issued Show Cause Notices u/s 4 of the Act (for adjudication of the prayer for recovery of possession etc. of the Public Premises), u/s 7 of the Act was also issued to O.P. (for adjudication of the prayer for recovery of arrear rental dues etc.), both issued as per Rule made under the Act, and both dated 08.02.2018. O.P. was asked to Show Cause on or before 07.03.2018.

It is seen from the said report that the notice under Section 4 and notice under Section 7 were duly received by one Kishan Kumar Shaw on behalf of Kamala Prasad Shaw on 16.02.2018 by putting his signature on the said notices. In my opinion KoPT's claim for damages from 18.10.2006 to 26.05.2017 for Rs. 5,13,046.58 (Rupees Five lakhs thirteen thousand and forty six and fifty eight paisa only) (excluding interest for delayed payment) for wrongful occupation may be payable by O.P. as it is gathered during the course of hearing and application dated 26.05.2017 filed by KoPT that the charges so claimed by KoPT are on the basis of the Schedule of Rent Charges published under the Authority of Law as per provisions of the Major Port Trusts Act 1963. In course of hearing, I find that KoPT has made out an arguable claim against O.P., founded with sound reasoning. I make it clear that Kolkata Port Trust is entitled to claim damages against O.P. for unauthorized use and occupation of the public premises upto the date of recovery of clear, vacant and unencumbered possession of the same in accordance with Law and KoPT is entitled to claim interest upon dues/charges right from the date of incurrence of liability by O.P. as per KoPT's Rule. KoPT is accordingly directed to submit a statement comprising details of its calculation of damages, indicating there-in the details of the rate of such charges together with the basis on which such claimed against O.P. are charges
