## FINAL ORDER

The instant proceedings No. 808/D of 2006 arises out of the application bearing No. Lnd. 4463/D/09/10/7015 dated 29.03.2010 read with an application dated 22.06.2007 filed by the Kolkata Port Trust (KoPT), the applicant herein, praying for an order of recovery of dues and other charges etc. along with accrued interest in respect of the public premises as defined in the Schedule of said application, against M/S Century Refrigeration Co, the O.P herein, under relevant provisions of Public Premises (Eviction of Unauthorized Occupants) Act, 1971.

The fact of the case in a nutshell is that the O.P. came into occupation of the Port property measuring 4214.45 sq.mtrs. or thereabout at Taratala, Thana-Taratala Police Station (under Plate Nos.D-376/1 and SF-100/44) as long term Lessee for 30 years which is more fully described in the 'Schedule-'A' of the KoPT's application dated 30.05.2006 as received by this forum 14.06.2006. The allegations levelled by KoPT against the O.P is that while in possession of Port property as long term Lessee, the O.P has defaulted in making payment of compensation and taxes and also accrued interest thereon the details of which has been given with the KoPT's application dated 22.06.2007.

Notices on the O.P. but O.P was not found in such addresses.

As none appeared on behalf of O.P or any other person interested in the property, a publication was made in the classified column of Times of India(Kolkata) on 22.10.2019 fixing the ultimate date of O.P's appearance on 01.11.2019. Finally as the O.P failed to appear on 01.11.2019 the final Order was reserved in the matter. Now this forum has decided to adjudicate the matter ex-parte.

As no one from O.P's side appears and no reply to the Show Cause Notice u/s 7 of the Act has been filed as yet, I have no bar to accept the claim of KoPT on account of damages/compensation etc. In fact, I have nothing to disbelief in respect of KoPT's claim against O.P. as per statement of accounts maintained regularly in KoPT's office in regular course of business.

It is my considered view that a sum of Rs.83,21,616.36 for the period 27.10.1994 to 24.04.2007(both days inclusive) for the respective plates in question is due and recoverable from O.P. by the Port authority on account of damages and O.P. must have to pay such dues to KoPT on or before 42.09.20 The said damages shall attract compound interest @ 6.20 % per annum, which is the current rate of interest as per the Interest Act, 1978 (as gathered by me from the official website of the State Bank of India) from the date of incurrence of liability, till the liquidation of the
