II. CARGO THROUGHPUT :

- SMP, Kolkata handled 55.033 million tonnes (mt) of traffic during April 2020- February 2021 vis-à-vis 58.568 mt during April 2019- February 2020, registering a fall of 6.04% in the aftermath of the serial lockdowns continuing during the outbreak of Pandemic COVID 19. Significantly, the fall in traffic (overall at SMP, Kolkata) which was around 23.74% till August'2020, has been arrested which has gradually narrowed down to 14.08% till October'2020 and further to 6.04% till February 2021, primarily due to robust traffic growths experienced by HDC during the intervening months. Iron Ore, Manganese Ore, Iron & Steel Products, POL (Crude), LPG, Finished Fertiliser, etc. through HDC and Other Coal / Coke, Iron & Steel and Pulses through KDS have been showing an increasing trend during April 2020- February 2021.
- HDC handled 41.104 mt of cargo during April 2020- February 2021 vis-à-vis 42.605 mt in April 2019- February 2020 (recording a 3.52% decrease). KDS handled 13.929 mt of cargo in April 2020- February 2021 vis-à-vis 15.963 mt during April 2019- February 2020 (12.74% decrease).

III. CONTAINER TRAFFIC :

- SMP, Kolkata handled 6,19,695 TEUs (KDS: 4,88,093 & HDC: 1,31,602) during April 2020- February 2021 vis-à-vis 7,89,128 TEUs (KDS: 6,30,394 & HDC: 1,58,734) during April 2019- February 2020, recording a fall of 21.47%.

IV. COMPARATIVE PERFORMANCE:

- SMP, Kolkata ranked 5th among Major Ports in cargo handling during April 2019-February 2020.
- The Port ranked 1st in Coking/Other Coal, 2nd in Other Liquids and 4th in Container handling among Major Ports.

V. SHIP TRAFFIC :

- During April 2020- February 2021, 2890 ships (KDS: 953, HDC: 1937) called at SMP, Kolkata. 3859 vessels (1937 inward; 1922 outward) passed through Eden channel in April 2020- February 2021 to / from Haldia.

V. RAILWAY TRAFFIC :

- During April 2020- February 2021, SMP, Kolkata handled rail-borne traffic of 25.27 mt (KDS-4.33 mt & HDC-20.94 mt) against 26.61 mt (KDS-4.54 mt & HDC-22.07 mt) in April 2019-February 2020 registering a fall of 5.04%. During April 2020-February 2021, 1015 trains were received and 1034 despatched at KDS; at HDC, 4237 trains were received and 4223 were despatched.
