As no one appeared on behalf of O.P. in terms of the said notice to represent their case or no reply to the Show Cause Notice has been filed on behalf of O.P., a notice was published in English Daily Telegraph" on 22.07.2015, inviting attention of all concerned regarding pendency of the proceedings before this Forum of Law.
