ii) Show cause notice vide letter no. Mech/DC-III/25/247/1073 Dated 22.08.2023

You had participated in the Tender No. SMP/KDS/Mech/SE-I/ADV/610 dated 07.07.2022 for "Electrical Installation work related to Illumination of proposed Dhobitalao Truck Parking facility at plot no. 6,7 & 8 of Dhobitalao, KDS, SMP Kolkata" of estimated value Rs. 34,20,737.00. In support of your credential, you had submitted Work order Memo no.136754/BDA, Bhubaneswar dt. 01.06.2019 of Bhubaneswar Development Authority, for "Supply, Installation and Commissioning of High Mast Lighting Tower with luminaries along with street light at different roads in Bhubaneswar" amounting to Rs. 84,78,942/-.Completion certificate dt. 12.02.2020 was submitted with value of executed work as Rs. 84,76,635.00.

During credential verification from Bhubaneswar Development Authority (BDA), in response to our letter requesting BDA to confirm the credential issued by them. BDA informed vide their email dt.06.09.2022 that no such work orders and completion certificate bearing memo no.136945/BDA, Bhubaneswar dt. 12.02.2020 has been issued by the office of planning member, BDA. As such, the work credential certificate uploaded by you bearing memo no. 136945/BDA, Bhubaneswar dt.12.02.2020 of BDA is proved to be ingenuine.

A show cause notice was issued to you vide letter no. Mech/DC-III/25/247/1073 Dated 22.08.2023, in response you have accepted vide Letter No.AU/SEPT-12/2023-24 Dated 01.09.2023 that you have submitted ingenuine credential against Tender No. SMP/KDS/Mech/SE-I/ADV/610 dated 07.07.2022.

Accordingly, the Competent Authority of Syama Prasad Mookerjee Port, Kolkata, hereby imposing banning of business dealing with M/s Ashim Udyog for a period of 2 (Two) years, from the date of Debarment i.e. 05.12.2023.
