5. PERFORMANCE HIGHLIGHTS

A. Cargo Traffic:

- **KoPT handled 16.221 million tonnes (mt) of traffic in Apr-Jun'19 vis-à-vis 15.229 mt in Apr-Jun'18 registering a growth of 6.51% - much higher than 1.52% growth for Major Ports. KDS handled 4.653 mt in Apr-Jun'19 vis-à-vis 4.438 mt in Apr-Jun'18 recording 4.84% growth while HDC handled 11.568 mt in Apr-Jun'19 vis-à-vis 10.791 mt in Apr-Jun'18 i.e. a growth of 7.20% - 2nd highest among Major Ports.**
- **KoPT had growth in Apr-Jun'19 w.r.t. Vegetable Oil, Other Liquids, Iron Ore, Other Ore, Fertiliser, Fly Ash, Other Coal/Coke, Gypsum, IVW Traffic, etc.**

B. Container Traffic:

- **KoPT handled 2,08,353 TEUs in Apr-Jun'19 (KDS: 1,64,861 TEUs and HDC: 43,492 TEUs) and ranked 3rd amongst all Indian Major Ports in terms of Container Traffic.**

C. Comparative Performance:

- **KoPT ranked 5th in Apr-Jun'19 in cargo handling amongst Indian Major Ports.**
- **KoPT ranked 1st in Coking/Other Coal, 2nd in Other Liquids and 3rd in Container handling among Major Ports.**

D. Ship Traffic:

- **In Apr-Jun'19, KoPT handled 898 ships - the highest among Indian Major Ports. 1118 vessels (559 inward; 559 outward) passed through Eden channel in Apr-Jun'19 to / from Haldia.**

E. Railway Traffic:

- **In Apr-Jun'19, KoPT handled rail-borne traffic of 7.476 mt. (KDS-1.314 mt & HDC- 6.162 mt) against 7.013 mt. (KDS-1.415 mt & HDC-5.598 mt) in Apr-Jun'18 registering a growth of 6.6%. In Apr- Jun'19, 309 trains were received and 309 despatched at KDS; at HDC, 1214 trains were received and 1214 despatched.**

F. Major Achievements:

- In order to reduce queuing of ships, one more anchorage at Sagar has been notified and vessels upto LOA 190 m can be accommodated at the new 4th Sagar anchorage of Kolkata Port. This is in addition to the existing 3 conventional anchorages at Sagar. The new lower Sagar anchorage (Point X) opened in 2018 for Cape size vessels.
- One more Mooring Buoy system has been commissioned at NS Dock of KDS to increase holding capacity in the Dock. Vessels of about 120 m LOA can be parked at this jetty.
- MT Sand Shiner brought POL (Crude) to HDC of KoPT after a long time for Numaligarh Refinery. Chairman, KoPT and Chairman, Numaligarh Refinery, received the vessel at HOJ-1.
- Container operations started at Khiddirpore docks, KDS of KoPT after more than a decade, with vessel MV Trans Samudera from Bangladesh, discharging containers on 22-23.4.2019 at 6 KPD.
- On 15.6.19, KoPT felicitated various Trade Partners for their exemplary performance in the field of Trade and Traffic for 2018-19, as a token gesture of recognition of their services in expansion of trade and commerce at KoPT, the very life-line of Eastern India.
- Aimed at better organizing our work place to boost productivity, 5S implementation has been started at KoPT with training conducted on 22.06.19 by Mr. H. K. Varma, Director, 5S Institute, Mumbai. Inaugurated by Chairman, KoPT and participated by senior officers of KoPT, the programme was a huge success.
- On World Environment Day (5.6.19), KoPT joined hands with 'PUBLIC (People United for Better Living in Calcutta) to put thrust on Urban Forestry programme. KoPT has pledged to make the planet greener through its humble initiatives involving development of a 1700 sqm. Mini forest at Dhobitalao / 2000 sqm landscaped forest at Taratala Labour Colony, land distribution to fishermen's Co-operatives for maintenance of water bodies, tree plantation, etc.
- To maintain sound health and promote corporate excellence, KoPT observed 5th International Yoga Day on 21.06.19 with CISF, trade partners, officials of KoPT at KDS and HDC, in accordance with the programme launched by MoS.
- Kolkata Port celebrated the World Heritage day on 18.4.2019 in association with Indian Museum, The National Library etc. The second Port Heritage Talk was delivered by eminent urban historian / cultural activist.
- The Hon'ble Consul Generals of Germany, Italy, France, Hon'ble Consul General of Australia and respected delegates from Bangladesh visited KoPT holding wide ranging exchanges on business/trade and developmental perspectives.
- Interchanging of Lock Gate work has been recently executed at HDC. The outer Lock Gate at HDC has been replaced with a new Lock Gate, which had started moving after 25 long years - a historic occasion for HDC.
