AND WHEREAS, no reply to the show cause notice has been filed as yet.



SCHEDULE

The piece and parcel of land measuring 194.446 sqm or thereabouts is situated at the lessor's Chetla Station Yard at Thana Chetla, District 24 Paraganas, Registration District Alipore. It is bounded on the north by lessor's roadway, on the east by lessor's vacant land, on the south by lessor's strip of open land along side their drain and on the west by the lessor's leased out land.
