Such prayer of O.P. is rejected since a number opportunity was granted to O.P. on the earlier occasions where O.P. miserably failed to vacate the quarter. As such, I have nothing to disbelieve the statement made against O.P. by the Port Authority. In fact, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority on the following grounds/reasons.

- 1. That nothing has been shown in support of O.P's occupation into the public premises.
- 2. That no evidence has been laid to support the possession of O.P. "authorized possession/occupation".
- 3. That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question.
- 4. That O.P has failed to hand over clear vacant and unencumbered possession of the subject quarter
