Sub: Reallocation of different gates at NSD Section for entry and exit of vehicles.

Container Terminal has been witnessing huge vehicular congestions almost daily except Sunday and holiday threatening vessel output and increasing TRT (Turn Round Time) of the working vessels including non-performing for non-vessel work like loading and unloading of containers at different yards.
