Taratala Kolkata – 700 088 and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

FINAL ORDER

It seen that O.P. last appeared on 20.03.2019 and prayed for time to surrender the subject quarter on or before 10.04.2019 to the competent authority of KoPT. But O.P. not only failed to appear before this Forum but also failed to honour his commitment to surrender the subject quarter to the officials of KoPT. As such, I have nothing to disbelieve the statement made against O.P. by the Port Authority. In fact, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority on the following grounds/reasons.

- 1. That nothing has been shown in support of O.P's occupation into the public premises.
- 2. That no evidence has been laid to support the possession of O.P. as "authorized possession/occupation".
- 3. That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question.
- 4. That O.P has failed to hand over clear vacant and unencumbered possession of the subject quarter
