The instant proceedings nos. 1380 & 1380/D of 2013 arises out of the application dated 06.11.2012 of the Kolkata Port Trust (KoPT), the applicant herein, praying for an order of eviction and recovery of dues and other charges etc. along with accrued interest against Sri Dhaneswar Rajbhar, the O.P. herein, under the relevant provisions of Public Premises (Eviction of Unauthorized Occupants) Act, 1971.

The facts of the case, in terms of a nutshell, are that the O.P. came into occupation of the port properties measuring 33.445 sqm or thereabouts (under plate no. D378/12) and 19.32 sqm or thereabouts (under Plate no. D378/16), both situated at the western side of Taratala Staff Colony, Thana -Taratala, Registration District: Alipore and District: 24 Parganas, (morefully described under the 'Schedule of Property' of the KoPT's application filed on 06.11.2012) as a month to month lessee and had defaulted in making payment of KoPT's dues and taxes and unauthorisedly parted with possession of the Public Premises in question to the rank outsiders. Subsequently, it was informed by KoPT that O.P. has also changed the purpose of the use of the Premises in clear violation of the terms and conditions of the lease in question.

It is the case of KoPT that the O.P. was asked to vacate the premises on the expiry of the month of August, 1983 in terms of the Quit Notices dated 20.06.1983, served as per statute upon the O.P. by registered post with acknowledgement due. 
On 27.03.2019, i.e. the day fixed under the Notice/s for appearance of O.P. for answering all material questions connected with the matter alongwith the evidence in support of the Cause Shown, one Sri Sunny Nandy, expressing himself as the Ld. Advocate of Sri Dhaneswar Rajbhar (without any authority or Vakalatnama or the Reply to Show Cause or any papers/ documents in connection with the case) made himself present but as the undersigned was not available due to other official engagement, the matter could not be heard. It appears from records that the re-fixed next date of hearing (i.e. 03.04.2019 at 12 noon) was duly intimated to the said Ld. Advocate (without authority) and the said Ld. Advocate also acknowledged the same by putting his signature in the pre-printed Hearing Notice. On 03.04.2019, however, none appeared on behalf of O.P. despite knowledge that the date was fixed for filing Reply to the Show cause notice, production of documents/ evidence and personal hearing. Furthermore, no reply/ documents/ evidence reached this Forum. Following the principles of natural justice, another opportunity was given to the O.P. by fixing the next date on 17.04.2019 to appear, file reply to the Show cause and the said order was served personally upon the subject property through Process Server and the same Sri Tripurari Shaw received the certified copy of the Order under acknowledgement, on 11.04.2019 as before. On 17.04.2019 again none appeared on behalf of the O.P., nor any reply / documents / evidence was filed before this Forum.

Since none appeared on behalf of O.P. despite opportunities being provided to them nor shown any interest in filing Reply to the show cause, and being satisfied with service of notice upon all concerned as per the mandate of the Act, the Final Order was reserved by this Forum on 17.04.2019.

Now while delivering the final order, I have carefully gone through the submissions of KoPT. It is noted that KoPT vide their original application filed dated 06.11.2012 and subsequently vide detailed statement of accounts, filed under the cover of KoPT's application

dated 15.03.2017 has drawn my attention to the fact that huge amount is lying outstanding with the O.P. I have also gone through the communications of the Port Authority addressed to the O.P., particularly the letters dated 04.04.1983 whereby the O.P. was repeatedly requested to liquidate the dues but, apparently, no heed was paid by the O.P. The most vital piece of evidence is of course, the admission of such dues on the part of the O.P. by a letter signed by the O.P. himself and received by the Port Authority on 13.08.1984 whereby the O.P. clearly confessed that due to his financial difficulties, he could not pay the dues in time. Such being the case, the contention of the Port Authority regarding non-payment of outstanding dues definitely bears the stamp of correctness. As regards the charge of unauthorised parting with possession, it is seen from the records that the Quit Notice, the Notice/s to Show cause as well the present orders/ communications were received/being received by persons other than the O.P., with one Sri Tripurari Shaw, introducing himself as 'sitting occupant', while acknowledging receipt of the Show Cause Notice, on behalf of Dhaneswar Rajbhar. This clearly suggests that O.P. is not in possession of the property at all and rather the property is being enjoyed by rank outsiders. Moreover, it is clear from KoPT's Inspection Reports dated 22.09.2017 and 28.01.2019 that various strangers are in possession of the property with no trace of O.P. in the premises. The premises are also found to be used for purposes other than the ones originally agreed into.

As such, after perusal of all these evidences produced by KoPT, there is no doubt or confusion in my mind that the monthly lease/s of the O.P. were rightly determined by the Port Authority vide Notice/s to Quit dated 20.06.1983. I think that all the breaches, as claimed by the KoPT, are very much established against the O.P. and consequently, I have no hesitation to hold that the Notice/s to Quit dated 20.06.1983 had been validly issued and served on the O.P. and the same are binding on the parties.

I make it clear that all person/s, whoever may be in occupation, are liable to be evicted by this order and the Port Authority is entitled to claim damages for unauthorized use and enjoyment of the property against O.P., in accordance with the Law, upto the date of recovery of possession KoPT is directed to submit a of the same. comprehensive status report of the Public Premises in question on inspection of the property after expiry of the 15 days as aforesaid, so that necessary action can be taken for execution of the order of eviction u/s 5 of the Act, as per Rule made under the Act.

I find that KoPT has made out an arguable claim against O.P., founded with sound reasoning, regarding the damages/compensation to be paid for unauthorised occupation. As such, I must say that Rs. 10,11,893.87/- and Rs 5,49,996.48/- (in respect of Plate nos. D378/12 and D378/16 respectively) as claimed by the Port Authority as damages, is correctly payable by O.P. for the period 01.09.1983 to 25.01.2019 (both days inclusive) for each of the Plates in question and it is hereby ordered that O.P. shall also make payment of the aforesaid sum to KoPT by 15.06.2019. The said damages shall carry simple interest @ 15% per annum upto 18.09.1996 and thereafter @ 18% per annum till 06.04.2011 and thereafter @14.25% per annum on the above sum from the date of incurrence of liability till its final payment in accordance with the relevant notification/s published in Official Gazette. The formal order u/s 7 of the Act is signed accordingly.
