WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that Sri. Narayan Chandra Sett, Sri Patit Paban Sett, Legal Heirs of Sri. Jotish Chandra Sett (O.P.) of Kuthirmath Barabazar, Chandannagar, Hooghly, West Bengal -712136 AND ALSO Block B-5, Jaganuath Chat Godown, Strand Bank Road, Kolkata-700 007 AND ALSO Sri. Patit Paban Sett, Legal heirs of Sri. Jotish Chandra Sett (Since Deceased) 15A, Robert Street, Kolkata-700 012 AND ALSO Block-B-5, Jagannath Ghat Godown, Strand Bank Road, Kolkata-700 007, is in unauthorized occupation of the Public Premises specified in the Schedule below:

REASONS

- 1) That O.P. has failed to liquidate the rental dues to the Port Authority within the prescribed period, for a considerable time, despite being repeatedly requested for its immediate liquidation.
- 2) That O.P. has violated the conditions of tenancy under monthly term lease, as granted by the Port Authority by way of not making payments of rental dues to SMP, Kolkata, at the time of issuing Ejectment Notice dated 03.11.2011.

- 3) That O.P. has unauthorizedly parted with the possession of the subject Public Premises by inducting unauthorized sub-tenants, without any approval of the Port Authority and failed to vacate the premises upon determination of the period as mentioned in the Notice to Quit dated 03.11.2011, as issued by the Port Authority.
- 4) That O.P. or any other person/s asserting any right through O.P has failed to bear any witness or adduce any evidence in support of their occupation as "unauthorized occupation", inspite of sufficient chances being provided.
- 5) That O.P. or any other person/s asserting any right through O.P. has lost its authority to occupy the Public Premises after expiry of the period as mentioned in the Notice to Quit dated 03.11.2011.
- 6) That the Notice to Quit dated 03.11.2011 as served upon O.P. by the Port Authority is valid, lawful and binding upon the parties.
- 7) That O.P. has failed to show any cause against the allegations of erecting unauthorized construction, encroachment into the Port Property, and inducting unauthorized sub-tenants.
- 8) That O.P.'s occupation has become "unauthorized" in the view of Section 2(g) of the said Act, 1971, and O.P. is liable to pay damages as claimed by SMP, Kolkata for wrongful use and enjoyment of the Port Property in question upto the date of handling over of clear, vacant and unencumbered possession to the Port Authority.
- 9) That O.P. or any other person interested in the property has failed to file any reply to the Show Cause Notice/s u/s- 4 & 7 of the Act, inspite of sufficient chances being provided to them.

A copy of the Reasoned Order No. 14 dated 15.05.2023 is attached hereto which also forms a part of the reasons.

NOW, THEREFORE, in exercise of the powers conferred on me by sub-section (1) of Section 5 of the Public Premises (Eviction of Unauthorized Occupants) Act, 1971, I hereby order the said Sri. Narayan Chandra Sett, Sri Patit Paban Sett, Legal Heirs of Sri. Jotish Chandra Sett (O.P.) of Kuthirmath Barabazar, Chandannagar, Hooghly, West Bengal -712136 AND ALSO Block B-5, Jagannath Ghat Godown, Strand Bank Road, Kolkata-700 007 AND ALSO Sri. Patit Paban Sett, Legal heirs of Sri. Jyotish Chandra Sett (Since Decembed) 16A, Robert Street, Kolkata-700 012 AND ALSO Block-B-5, Jagannath Ghat Godown, Strand Bank Road, Kolkata-700 007, and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

FINAL ORDER

The matter is taken up today for delivering Final Order

The instant Proceeding Number 1413, 1413/R, and 1413/D of 2013 arises out of the application bearing no. Lnd.3348/49/12/1517 dated 02.05.2012 and another application bearing No.3348/49/23/662 17.03.2023 - both filed by Syama Prasad Mookerjee Port, (erstwhile known as Kolkata Port Trust), hereinafter referred to as SMP, Kolkata, the applicant herein, praying for an order of recovery of Eviction and recovery of outstanding dues on account of rent, damages, compensation charges, etc. alongwith with 5 accrued interest thereon, in respect of the Public Premises as stated in the Schedule - "A" of the said application dated 02.05.2012, against Sri. Narayan Chandra Sett, Sri Patit Paban Sett and Sri Jotish Chandra Sett, (hereinafter referred to as the O.P.) herein, under the relevant provisions of the Public Premises (Eviction of Unauthorized Occupant) Act, 1971 (hereinafter refer ed to as "the Act").

The **factual** matrix of the case is required to be put forward in a nutshell to link up the chain of events leading to this Proceeding Nos. 1413, 1413/R, and 1413/D of 2013, within the four corners of Public Premises (Eviction of Unauthorized Occupant) Act, 1971, as revealed under point-wise in a chronological order.

1) That it is the case of SMP, Kolkata, that the OP. came into occupation of the Port Property, measuring about 160.44 sq. mtrs or thereabouts situated at Siding No.15, Shalimar Coal Yard, Thana-Shibpur Police Station, District-Howrah, under Plate No.HL-384, (as described in details in the "SCHEDULE-A" of SMP, Kolkata's application dated, 02.05.2012) as a monthly tenant on certain terms and conditions. SMP, Kolkata has submitted in an application bearing No. Lnd.3348/49/12/1517 dated 02.05.2012, that while in possession of the Port Property as lessee, O.P. grossly violated the condition of such lease by way of default in making the payment of the rental

dues and taxes to SMI, Kolkata for use and enjoyment of the Port Property in question, the details of which has been given in "SCHEDULE-B" of SMP, Kolkata's application dated 02.05.2012.

- 2) That SMP, Kolkata had also submitted an application bearing No. 3348/49/23/662 dated 17.03.2023, whereby it alleged that during an inspection-cum-survey dated 01.03.2023 at the subject premises, it was observed that the said premises was under lock and key and that on the entire occupation a CIR Godown has been erected, without having any prior approval from SMP, Kolkata.
- 3) That in view of such aforesaid breaches committed O.P., and several written communications/reminders given to O.P. for payment of their rental dues, SMP, Kolkata issued Notice to Quit dated 03.11.2011, requiring O.P. to quit, vacate and deliver up peaceful possession of the premises on 15.12.2011 in terms of the Notice dated 03.11.2011. SMP, Kolkata submits that O.P. has no authority under Law to occupy the Public Premises after determination of the lease period and was required to hand over the possession of the property in question to SMP, Kolkata on 15.12.2011 as required under the said Notice to Quit dated 03.11.2011.
- 4) That it is the case of SMP, Kolkata that in terms of the Notice to Quit dated 03.11.2011, and inspite of the determination of the said tenancy, O.P. failed and neglected to quit, vacate and deliver up the vacant peaceful possession of the said premises and was occupying and holding the property in question wrongfully without any valid authority. SMP, Kolkata has made out a case that O.P. has no right to occupy the premises after the determination of the tenancy in question upon service of Notice to Quit dated 03.11.2011. It is also the case of SMP, Kolkata that O.P. is in wrongful occupation in the public premises on and from 15.12.20211 and is liable to pay compensation charges/mesne profits

- 5) That during the course of the proceedings, SMP, Kolkata verbally as well in written vide application bearing No. No.3348/49/23/662 dated 17.03.2023 submitted that there are no Court cases pending before any Court of Law and also there are no Restraining Orders, in relation to the concerned subject premises. As such, this Ld. Forum formed its opinion and proceeded with this matter under the relevant provisions as laid down in the said Act, 1971.
- 6) That considering the submission advanced by SMP, Kolkata and the documents-on-record, this d. Forum formed its opinion to proceed against OP. under the relevant provisions of the Act, 1971, and issued three (3) Nos. of Show Cause Notices all 20.03.2023 (Vide Order No.11 dated 20.03.2023) upon O.P., u/s-4 (for adjudication of the prayer of eviction) and u/s-7 (for adjudication of the prayer for outstanding rent as well as damages/compensation/charges) of the Act, as per the Rules made under the Act. The Notice/s were issued in terms of the said provisions of the Act calling upon the O.P. to appear before this Lt. Forum in person or through authorized representative capable of answering all material questions in connection with the matter, along with the evidence which the opposite party intends to produce in support of their case.

rent charged from time to time is based on the rates notified by the Tariff Authority for Major Ports (TAMP) in the Official Gazette, which is binding on all users of Port Property. Non-payment of the rental dues by O.P. is very much prominent and established, as stated above. As per Law, a short term lease tenancy, like the one granted to O.P. continues only on the basis of timely payment of rent bill/s and non-payment of the same, even for a small period is enough to vitiate the contract. The moment O.P. delays to pay the rent, there is no scope for automatic monthly renewal of the tenancy. In my view, the breach committed by the O.P. is very much well established in the facts and circumstances of the case, and O.P. must suffer the consequences, following due applications of the tenets of Law. Such a tenancy is to be determined immediately by service of appropriate Notice. As such, I do not find anything irregular or illegal on the part of SMP, Kolkata. In my view, SMP, Kolkata's Notice to Quit dated 03.11.2011 is very much pertinent and binding upon the parties in question, duly served upon O.P. as per records. Thus, I have no hesitation in upholding the suid Notice to Quit and declaring the occupation of O.P. as "unauthorized" within the meaning of Section 2(g) of the Public Premise (Eviction of Unauthorized Occupants) Act, 1971.

A question may arise as to how far the service to the Show Cause/s deserves merit in the facts and circumstances of the case. After a through perusal of all the records in the case, I have left with no other alternative than to accept that the said Notice/s have duly been served upon O.P by way of affixation. As already stated in Point No.7 of this Order, that I am satisfied with the service of the Notice to all concerned.

As regards the allegations of non-paymen by O.P., I find that SMP, Kolkata has produced Statement of Accounts (including rent for the per od as described in the Schedule attached with this Order and outstanding Dues/Damages/compensation for the prescribed period also described in the Schedule as attached with this Order) dated 02.05.2012 and 17.03.2023 in respect of the said occurations. 13) That considering all, as discussed above, and as no one from O.P.'s side appears and no reply to Show Cause Notice u/s-4 & 7 of the Act has been filed as yet, I have no bar to accept the claim of SMP, Kolkata and also nothing to disbelieve he statement made against O.P. by the Port Authority, on account of unauthorized occupation of O.P. into the Public Premises in question. Hence, I am eft with no other alternative but think it as a fit case for issuing Order of Eviction u/s-5 of the Act, 1971, against O.P., as prayed for on behalf of SMP, Kolkata on the following grounds/reasons:-
