Sub: "Procurement, Installation and Commissioning of two (2) no's AIS Receiver with accessories along with three years warranty period for Haldia & Sagar VTMS stations under Hydraulic Study Department (HSD) of Kolkata Port Trust (KoPT)"

Ref: Our NIT No. No. Hyd/8054/72 dated 31.01.2019 ,
Your E-tender offer no. 3Stechs/S&M/1819/QTN/520 dated 05.03.2019 and all other correspondence in this regard

Reference above, your offer has been accepted by the competent authority for the work supply, installation and commissioning of two (2) no's AIS receiver (Model: AIS 9000 Transponder) with all accessories along with three years warranty period, as per the terms and conditions of the NIT, at a total cost of Rs. 9,76,962/- (Rupees Nine Lakh Seventy Six Thousand Nine Hundred & Sixty Two) only plus GST as applicable for VTMS outstations at Haldia and Sagar under Hydraulic Study Department (HSD) of Kolkata Port Trust (KoPT). The salient terms and conditions for the captioned work are mentioned below:

1. The following items are to be supplied, commissioned and tested at site:

- (i) At Haldia VTMS: Supply, installation & commissioning of AIS Receiver (Make: AIS 9000 Transponder) along with GPS Antenna with 30 meter antenna cable (Cable Type: RG 58 /RG 59), VHF antenna (3 dB or better) with 30 meter cable (Cable Type: LMR 400), other accessories such as power cable, AC-DC converter, interface cable, antenna mounting brackets etc as per NIT.
- (ii) At Sagar VTMS: Supply, installation & commissioning of AIS Receiver (Make: AIS 9000 Transponder) along with GPS Antenna with 30 meter antenna cable (Cable Type: RG 58 /RG 59), VHF antenna (3 dB or better) with 60 meter cable

(Cable Type: LMR 400), LAN cable (Type: PoE CAT 6) of 150 meters length, other accessories such as power cable, AC-DC converter, interface cable, antenna mounting brackets etc as per NIT.

2. Compliance of NIT Specifications:

There should be no provision of transmission in AIS Receiver (Make: AIS 9000 Transponder). The transmission facility should be disabled before supply/commissioning. During installation customized mounting bracket for antenna installation over tower at Halida & Sagar is to be provided. All other items to be supplied (as mentioned in your offer) are to be in compliance with specifications as mentioned in the NIT under reference.

3. Payment Terms:

The 90% of the payment for the supply, installation, commissioning etc. will be paid after satisfactory completion and acceptance of the system in totality, on submission of bill in quadruplicate along with commissioning certificate in totality to the office of Chief Hydraulic Engineer, Hydraulic Study Department, 20 Garden Reach Road, Kolkata-700043 and remaining 10 % will be paid after satisfactory completion of warranty period of three years.

4. DAP (Delivery at Place)

Please note that equipments in totality are to be delivered with requisite insurance etc at respective site of Kolkata Port Trust as mentioned below:

- a. VTMS Station at Haldia – Jawahar Tower (top floor), Haldia Township, Dist: Purab Medinipur- 721607
- b. VTMS Station at Sagar – Sagar Light House Campus, Village: Beguakhali, P.S: Sagar Costal, Dist: 24 Parganas (S) – 743373

5. You are supposed to bear all Indian corporate and personnel taxes in case of applicability as per provision of the Indian Income Tax with amendments if any thererof.

6. You are also requested to note that for the instant contract i.e. supply and maintenance of the AIS receiver and accessories all relevant Indian Acts those are applicable for execution of the work are to be dealt from your end.

7. Please note that you will be guided by the terms and conditions of General Conditions of Contract, Special Conditions of Contract, all other particular specification etc as referred in NIT.

8. Liquidated Damage (LD):

Please note that this is turnkey job. The work, procurement, installation & commissioning of two (2) no's AIS Receiver (Model: AIS 9000) with all accessories for respective sites, as per BOQ should be completed in all respect on a turnkey basis to the satisfaction of the Engineer within thirty (30) days from the date of acceptance of work order. Failure to complete the work in totality within the due date will attract relevant provision of the LD clause as mentioned in Tender Document.

9. Warranty period of three (3) years has to be provided as per conditions of tender, failure to do so will attract relevant provision of penalty, risk purchase clause etc, as mentioned in the Tender Documents. In the warranty period, equipment should be restored within three (3) working days after reporting of fault. In case of failure to restore the equipment within specified time, will attract imposition of penalty @ ½ % of prorata value for every week or part thereof for non functioning of each set, subject to a maximum of 10% of the total cost. Penalty amount will be deducted from the security deposit.

10. The AIS receiver with all accessories is to be warranted as per terms and conditions of NIT for a period of thirty six (36) months, after the date of satisfactory acceptance.

11. You are required to enter into a formal agreement with KoPT within fifteen (15) days from the date of acceptance of work order, on a non-judicial stamp paper of Rs. 100/- (Rupees One Hundred Only). The cost of stamping Agreement shall be borne by you.

12. You may get in touch with Shri S. Yadav, Executive Engineer (033-71003532) of this department for taking work in hand.

This may please be treated as formal Work Order and you are requested to return one set of the same duly signed and stamped in all pages of instant work order as a mark of acceptance.
