- vii. Contact No.(Mobile) for SMS facility

viii. Email ID- For immediate intimation regarding access credential (Login ID & Password) as well as Online bill facility.

After successful payment an e-receipt will be generated by the web-based system. For final adjustment of amount paid as well as for collections of Treasury Receipt, reconciliation of payment or any dispute the user is requested to contact Finance Division's office. As per RBI guidelines information regarding transaction charges is also available in web-based payment gateway. All concerned are requested to verify all details before clicking to "proceed" for payment.

All concerned are requested to extensively use the web-based E-Payment gateway for payment of Land/Estate/Quarter Rent with effect from 01-12-2018.
