Sub: Cashless supply of out of stock Allopathic medicines at the Centenary Hospital, SMP, Kolkata, in PPP Model.

- 1) M/s. MARS' Remedies has been selected as a vendor for cashless supply of out of stock Allopathic medicine at the CH from 12.07.2021.
- 2) Accordingly, they have established a private pharmacy outlet at the ground floor of CH, SMP, Kolkata, which will start operating from 12.07.2021.
- 3) As previously, all in stock and tendered medicines will be supplied by the hospital pharmacy 24 hours a day. Only out of stock medicines prescribed by doctors, which were to be purchased by the patient from the market, will be supplied by the MARS' Remedies on cashless basis from henceforth, 24 hours a day.
- 4) Consequently, the need for application for re-imburement will also stop. At the end of the month, M/s. MARS' Remedies will submit the relevant documents of supplied medicines to SMP, Kolkata, through CMO and will get the payment directly. This will be beneficiary for the patients and also for SMP, Kolkata, as the private pharmacy will allow a concession of 22% on MRP all medicines and accessories.
- 5) Brand swapping is not allowed by the pharmacy, if any particular brand is not available the doctors can change it. Otherwise, MARS' Remedies is to purchase the brand from the market and supply it. In case of failure of supply within this stipulated time a penalty will be levied on MARS' Remedies.
- 6) The delivery of Allopathic medicine in most cases will be made instantaneously to the patient. On exceptional occasions, it shall be made available the same day or latest by the next day. In case of emergency, the medicines may be delivered at the residence of the patients in Kolkata as directed by the Medical Officer.
- 7) Any inconvenience may be brought to the notice of Dr. S. Gupta, Sr. Dy. CMO-II (I/C) or Dr. Rajat Mallick, Dy. CMO and O/C OPD.
