**Introduction:** Ministry of Ports, Shipping & Waterways (MoPSW), Govt. of India through Syama Prasad Mookerjee Port, Kolkata(SMPK)proposes to develop a Greenfield International Container Transshipment Port in Galathea Bay at Great Nicobar island of Union Territory of Andaman & Nicobar Islands

**Expression of Interest (EOI):** SMPK is the nodal agency for undertaking development of proposed port project and managing the port in landlord mode. SMPK, on behalf of Andaman and Nicobar Islands Integrated Development Corporation Limited (ANIIDCO), invites interests and suggestions from organizations or consortium of organizations having relevant technical expertise, financial capability, operational experience required for development, operation, maintenance and profitable growth of the proposed project under Landlord framework.

SMPK is interested to finalize the project structure and qualification criteria after taking views of the interested applicants. Based on the responses received, Request for Qualification (RFQ) /Request for Proposal (RFP) and Draft Concession Agreement document will be prepared and will be circulated for bidding purposes.

### 1 PROJECT INTRODUCTION

## 1.1 Background

- 1.1.1 The government of India under the Island Development program envisions taking up holistic development of selective islands. As part of the holistic island development plan, **Great Nicobar Island** (the southernmost Island of India) has been selected for development of the four projects namely Port, Airport, Township & Power plant. The environmental clearance for these projects has been accorded.
- 1.1.2 The Great Nicobar Island is only 40 nautical miles from the Malacca Strait international shipping channel. About 35% of the annual Global Sea trade is trough Malacca strait. It shall cater to the transhipment traffic from ports along east coast of Indian ports, Bangladesh and Myanmar as It is closer than Port Klang and Singapore. There is a huge opportunity for setting up of Deep Draft Container Transhipment Terminal at the Galathea Bay, for which Detailed Project Report has already been prepared.
- 1.1.3 The proposed location at Galathea Bay has three (03) distinct advantages to be established as a leading container transhipment hub.
  - Strategic Location Strategic Location on the Trade route, midway between existing transshipment terminals (Singapore, Klang, Colombo etc.) and Feeder Ports.
  - Water Depth Natural depths of over 20 m available.
  - Cargo Potential to capture transhipment cargo from Indian East Coast ports, Bangladesh & Myanmar.
- 1.1.4 The economic scale effects in container shipping have led to a rapid increase in size for all types of vessels, from feeders to the large inter-continental carriers. Therefore, the proposed port is planned such that bigger vessels (~28,8400 TEUs) could be handled. The proposed port is envisaged to be an all-weather deep seaport and provide water depths of over 20 m below CD to handle even bigger vessels in future. The proposed transshipment port, with its higher draft, additional capacity and greater efficiency, will provide an alternative option to shipping lines for containers transshipment. Further, the proposed infrastructures facilities shall be such that the service levels and facilities match with that of the global top container transshipment terminals and neighboring ports.

- 1.1.5 SMPK in association with ANIIDCO proposes to develop the port preferably via Landlord mode wherein the common / basic infrastructure may be developed by the "Authority" &The Concessionaire shall be responsible for design, Construction / Procurement, finance, operation & maintenance of proposed Container Handling Equipment, Container Yard, Onshore Utilities etc. required for Phase-I development of the ICTP, under a long-term concession through SMPK.
- 1.1.6 The Authority shall provide the reclaimed area for the development of the container yard. Concessionaire shall have the flexibility to develop storage area, container handling equipment and other infrastructure based on concessionaire's own market and business assessment subject to the Minimum Guaranteed Traffic as specified in RFQ to be floated subsequent to the present EOI.
- 1.1.7 The Concessionaire would be awarded a long-term PPP concession of 30 to 50 years (based on requirement) for the development, operation and maintenance of the container handling facilities envisaged in Phase-I development of the port.
- 1.1.8 The Concessionaire shall be responsible for the provision(s) of port services and shall have the rights to levy, collect and retain charges from port users. Further, he shall have freedom of fixing and revising tariff for its various offered port service(s).

### 1.2 Details of the Proposed Site

- 1.2.1 Galathea Bay is located in Great Nicobar Island of the Union Territory of Andaman and Nicobar Islands, India which lie in the eastern Indian Ocean (Bay of Bengal). These islands are an archipelago of about 836 offshore islands &Great Nicobar is the southernmost island of the archipelago.
- 1.2.2 Being the largest of the Nicobar Islands and the southernmost part of India, the Great Nicobar Island is situated between 6°45' and 7°15'N latitudes and 93°37' and 93°56'E longitudes and is located in the Nicobar District (one among the three districts of Andaman & Nicobar Islands). The tehsil stretches across Great Nicobar Island. The island has an area of about 910.074 Sq.km with approximate dimensions of (53X27) km. The proposed port is located at Galathea Bay as shown in shown in Figure-1.




Figure-1: Location of Proposed Port

- 1.2.3 The headquarters of the Great Nicobar Island is Campbell Bay, where most of the government offices are situated. It takes approximately 2.5 hours from the nearest airports in cities like Kolkata, Chennai, Vishakhapatnam, and Benguluru to reach the Veer Savarkar International Airport, located at Port Blair in Andaman. From there a helicopter or Dornier can be taken to reach INS BAAZ at Campbell Bay in Great Nicobar Island, which again takes 2.5 hours. Jetties at Phoenix Bay and Haddo wharf operate ferries connecting from Port Blair to Great Nicobar Island and it takes about one day to reach Great Nicobar Island.
- 1.2.4 A Greenfield International Airport (4000 Peak Hour Passengers-PHP) has also been planned as part of holistic development of Great Nicobar Island which will be developed simultaneously with the port. In addition to the port & airport, a power plant and township also are part of the holistic development of Great Nicobar Island as shown in Figure-2.




Figure-2: Overall Layout of the Proposed Development Plan at GNI

# 1.3 Details of the Proposed Container Transshipment Port




Figure 3 Layout of the Phase 1 Port Development

1.3.1 The facilities of the proposed container transshipment port have been planned as per the Detailed Project Report prepared for the project. The layout of the Phase 1 development of the port has been presented in **Figure 3**.

- 1.3.2 The project facilities are proposed to be developed in 4 phases. It is envisaged that phase 1 of the project would be developed to handle traffic of about 4 MTEUs in the year 2028, increasing to 16 MTEUs in the ultimate stage of development envisaged during year 2058.
- 1.3.3 The broad details of the Key port facilities in Phase-I developments are given below:
  - Two Breakwaters of about 3Km length.
  - A navigational channel of 400m wide and a turning circle of 800 m diameter.
  - About 125 Ha of Reclaimed Land for development of container yard and other allied infrastructure facilities like terminal buildings, workshops etc.
  - Total container berth length of about 2.3 km
  - RMQCs on berths, RTGs in container yard and other container handling equipment.
  - Onshore utilities like Water supply, fire-fighting system, drainage, sewerage system, Power Supply and distribution system, IT infrastructure etc.

- 1.3.4 There is also a provision to develop two liquid cargo berths to support bunkering operations, Ship repair facilities, FTWZ etc.
- 1.3.5 Due to existence of the port and airport at close proximity there could be a restricted aircraft movement if the Port cranes height exceed 150m. The maximum crane height currently envisaged at the port is 135 m. The applicant may suggest their views and opinion on the height restriction imposed by aircraft operations.
- 1.3.6 The overall estimated capital cost for the Phase-I development of the proposed transshipment port is around INR 18,000 crores which includes construction of breakwaters, dredging, reclamation, berths, storage areas, building and utilities, procurement and installation of equipment and development of port colony.

- 2.1 It is envisaged that the Applicant shall be a company or consortium of companies having experience in development of port infrastructure and/or core infrastructure projects and/or operation and maintenance of port terminals and/or involvement in cargo logistics operations and/or mainline container operator.
