2. For No.1 Haldia Oil Jetty - Upto 170 mtrs. LOA and draft upto 7.0 mtrs.
3. IT IS EXPECTED VESSELS WILL BE FULLY EQUIPPED WITH SUITABLE RADARS ETC. FOR BERTHING AT NIGHT.
4. IT IS COMPULSORY FOR MASTER TO PROCURE ESTUARY RIVER CHARTS THROUGH THEIR AGENTS FOR THE SAFETY OF THEIR VESSELS.
5. Night draft apply to tides available between Sunset on that day and Sunrise the following day.
6. All vessels to ensure that their engines, steering etc. are in good working order.
7. Pilot embarkation at EDEN Channel.
8. All vessels A.I.S. Pilot plug required to be operational.
