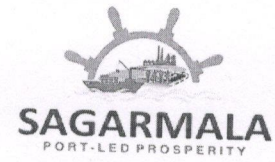

**TRADE CIRCULAR**

**Sub : Relaxation in compulsory weighment of dry bulk cargo during delivery.**

In the Trade Circular no. T.O.(Sh&CH)/10/3850 dated 18.11.2019, it was informed to all Importers of dry bulk cargo as well as all associated agencies at HDC that from 01.12.2019 onwards there will be compulsory weighment of vehicles carrying import dry bulk cargo while taking delivery from Dock except for direct delivery from the Hook Point of the vessel and for cargo on account of local industries located in and around Haldia.

While the local industries include IVL Dhunseri Petrochemical Industries Ltd., Electrosteel Casting Ltd., Petrocarbon and Chemical Pvt. Ltd., IRC Agro Chemical Pvt. Ltd., The Ramco Cements Ltd. etc. who are importing dry bulk cargo through HDC, the appropriate authority of KoPT have further approved delivery of **Fertilizer** and **Cement Clinker** to be kept out of the ambit of compulsory weighment at the time of delivery from Dock.

However, the eligible importers must submit an application for availing such relaxation from HDC Authority undertaking that they will be solely responsible for the cargo and no claim will be made by them in case of cargo shortage from the Final Draft Survey Quantity.

Besides the above, there will be compulsory weighment of all other dry bulk cargo, which will be guided by the Trade Circular no. T.O.(Sh&CH)/10/3850 dated 18.11.2019.
