Sub: Renewal of Policy for allocation of MHC equipped Berths as per availability of Storage Area.

Ref: This office's earlier Trade Circular issued vide no. TO (Sh & CH)/10/3241 dated 03.10.2019.

The Competent Authority of KoPT have further approved the extension of validity of policy for allocation of MHC equipped Berths to vessels considering the location of plots, in order to avoid crisscross movement of cargo carrying vehicles inside the dock by compromising the seniority of vessels, by keeping them waiting at Sandheads for one forthcoming tide with the approval of General Manager (Traffic) and for the second tide, with the approval of Deputy Chairman, HDC. The said policy is now valid for a further period of **one year w.e.f. 01.01.2020.**

**Sub : Renewal of policy for allocation of MHC equipped Berths
as per availability of storage area.**

This has reference to this office's earlier Trade Circular issued vide no. T.O.(Sh & CH)/10/2465 dated 29.07.2019.

The Competent Authority of KoPT has approved extension of validity of policy for allocation of MHC equipped Berths to vessels, considering the location of plots in order to avail criss-cross movement of cargo vessel inside the Dock for which seniority of the vessels may be compromised for few tides. The said arrangement shall be valid upto 31.12.2019 after which the same will be reviewed.

Needless to mention that commodity wise allocation of berths has already been extended w.e.f. 16.06.2019 till further amendment/ modification is found necessary and the same has already been circulated vide this office Trade Circular referred above.
