Trade Circular

Sub : Continuation of the Scheme for granting Handling Agency License for rendering Shore Handling Services at HDC.

This has reference to this office's earlier Trade Circular vide No. T.O.(Sh&CH)/10/1115 dated 07.05.2020 wherein it was communicated that the validity of the Handling Agency Licenses were extended up to 30.06.2020.

The Competent Authority of KoPT has further approved extension of validity of Handling Agency Licenses (issued to Ripley & Co., Netincon Marketing Pvt. Ltd., A.M. Enterprises, Orissa Stevedores Ltd. and Orissa Manganese & Minerals Ltd.) w.e.f. 01.04.2020 till notification of the new Stevedoring & Shore Handling License Regulations' 2016. The Handling Agents whose License has been extended will be required to pay to HDC, royalty on the cargo handling operation undertaken by them @ 12.36% of the Ceiling Upfront Tariff approved by TAMP and notified vide Gazette notification no. 76 dated 26.02.2018 and 246 dated 11.07.2019.
