Subsequently the physical copy with original signature should be sent by the concerned beneficiary to this office by post/hand within 04.02.2021.

In case the required information, as aforesaid, is not received from any such beneficiary within the time stipulated, the existing bank account details of such beneficiary will be used for the purpose of payment of pension and in that case any possible failure in transaction of pension due to lack of updated/revised information can not be ruled out.
