TRADE CIRCULAR

SUB: Payment of Port Charges through PCS1X only w.e.f. December 01, 2022.

This is to inform all valued customers of SMP Kolkata, HDC, that port charges paid through PCS 1X Payment Gateway gets credited to the deposit account of concerned parties in seamless manner, in time, without requiring any manual intervention. As the system started operating successfully a trade circular dated March 16, 2020 (Copy enclosed) was issued long back for mandatory use of the same for payment of port charges. Several mails have also been sent in this regard post issuance of said trade circular requesting our customers to shift to PCS 1X Payment Gateway for effecting payment of port charges.

2. It has been observed that some of our port users are still making payment of port charges through RTGS/NEFT mode instead of through PCS Payment Gateway despite repeated requests.

3. In view of above, it has now been administratively decided that **all Cargo, Marine, Railway and Estate (Parties having LCAN only) related payments shall be accepted through PCS 1X Gateway only w.e.f December 01, 2022.** Please note that SMP Kolkata, HDC, shall not be held responsible for any consequences arising out of delay in treasury receipt generation due to any failure on their part to shift to PCS 1X payment gateway within the aforesaid time frame.

4. All port users who are presently continuing to make payment of port charges through RTGS/NEFT mode are once more advised to get itself registered with PCS 1X, if not done yet, and start making payment of port charges through the said gateway. TRADE CIRCULAR

SUB: Mandatory use of PCS 1X Payment gateway w.e.f 01.04.2020

PCS 1X payment gateway was made operational w.e.f 11-12-2018. However, after a number of customers reported delay in getting credit against money paid to Port due to technical issues relating to the new payment gateway, Haldia Dock Complex started accepting payment of port charges through RTGS/NEFT mode also in addition to PCS 1X payment gateway.

However, it is now observed that the PCS 1X payment gateway has stabilized and payments made by customers to Port are getting credited in time. As getting credit against payment made through PCS 1X does not require any manual intervention, the gateway is presently being used by a number of customers.

In view of the above, it has now been decided to discontinue the system of accepting payment of Port charges directly to Bank Account of Port through RTGS and to accept payment of Port Charges relating to **Vessel, Cargo, Container and Railway Related Services** as well as payment to **LCAN Account** towards short term allotment in Dock Interior Zone, only through PCS 1X with effect from 01 April 2020. The Customers are requested to start using the PCS 1X payment gateway for making the said payments to HDC.

It may kindly be noted that w.e.f 01 April 2020, use of PCS 1X will be mandatory for making payment of the said Port Charges of Haldia Dock Complex.
