Sub: DPD Policy for the Financial Year 2019-20.

Direct Port Delivery Policy (DPD) for the financial year 2019-20 for Kolkata Dock System (KDS) is as below:

Customs AEO Clients and granted AEO status by Kolkata Customs vide the PN 04/2018 (**Annexure-I & II**) shall qualify to avail DPD facility from the Dock. The AEO Clients shall take direct delivery from the docks within 48 Hours after the date of landing of containers, beyond which their DPD status shall be withdrawn and the containers may be removed to the line nominated/importer nominated CFS. However they, after pass out, may take delivery of such containers upto four (4) days after the date of landing. Any addition to the list of AEO clients in the Kolkata Customs PN 04/2018 should be brought to the notice of Kolkata Port by submitting the AEO certificate issued in their favour.

Top Twenty (20) Volume Importers at KDS in the previous financial year (2018-19) shall be given the status of DPD clients. However, they have to get themselves authorized as DPD in terms of PN04/2018. These clients shall take delivery from the docks within 48 hours after the last landing date of containers, beyond which their DPD client status shall be withdrawn and the containers may be removed to the line nominated / Importer nominated CFS. However, after pass out they may take delivery of such containers up to four (4) days after the last landing date.

FALTA SEZ containers shall take delivery within five (5) days after the last date of landing.

For Exempted Categories of DPD clients furnished below there shall be no stipulated time within which removal to be affected. The stay period for these categories shall be till delivery.

- i) **Bharatiya Reserve Bank Note Mudran (P) Ltd.**
- ii) **Department of Posts, Govt. of India (Foreign Mail Only)**
- iii) **ICD (Indian & Nepal) bound containers.**

Both Nepal rail and road bound import load containers will enjoy DPD till delivery.

Bhutan road bound import containers will auto qualify for DPD from Docks and shall take delivery within 10 days after the last landing date.

Domestic Cargo Carrying containers will qualify for availing DPD and are to be removed from docks within 4 days after the last date of landing beyond which their DPD status will be withdrawn.
