



### आदेश

(अक्टूबर 2013 के 29वें दिन पारित)

यह प्रकरण कोलकाता पत्तन न्यास के प्रचलित दरमान की वैधता के विस्तार से संबंधित है।

2. केओपीटी के प्रचलित दरमान को इस प्राधिकरण द्वारा पिछली बार आदेश सं. टीएमपी/6/2010-केओपीटी दिनांक 29 नवंबर 2010 के जरिये अनुमोदित किया गया था जिसे भारत का राजपत्र में 15 फरवरी 2011 को अधिसूचित किया गया था। वह आदेश दरमान की वैधता 31 मार्च 2013 तक प्रदान करता है। बाद में, केओपीटी के प्रचलित दरमान की वैधता इस प्राधिकरण द्वारा दिनांक 9 मई 2013 के आदेश के जरिये 30 सितंबर 2013 तक विस्तारित की गई थी।
3. दिनांक 30 जनवरी 2013 के अपने पत्र के जरिये केओपीटी द्वारा दाखिल प्रस्ताव संबद्ध उपयोगकर्ताओं/ उपयोगकर्ता एसोसिएशन के साथ परामर्श के लिए लिया गया है। दिनांक 22 मई 2013 के हमारे पत्र के जरिये केओपीटी से मांगी गई अतिरिक्त सूचना/स्पष्टीकरण पत्तन द्वारा दिनांक 14 अगस्त 2013 और 20 अगस्त 2013 के उनके पत्रों के जरिये दे दी गई हैं। प्रस्तुत उत्तरों की जांच की जा रही है और इस प्राधिकरण के विचारार्थ परिपक्व होने में प्रकरण को कुछ समय लग सकता है।
4. उपरोक्त स्थिति को देखते हुए यह प्राधिकरण, दिनांक 9 मई 2013 के आदेश में वर्णित कारणों से 4% की विशेष दर के साथ केओपीटी के प्रचलित दरमान की वैधता 31 दिसंबर 2013 तक अथवा संशोधित दरमान के क्रियान्वयन की प्रभावी तिथि तक, इन में से जो भी पहले हो, विस्तारित करता है।
5. इसकी निष्पादनता की समीक्षा के दौरान, 1 अप्रैल 2013 के बाद की अवधि के लिये स्वीकार्य लागत और अनुमेय प्रतिलाभ से अधिक यदि कोई अतिरिक्त अधिशेष केओपीटी के पास जमा होता है तो वह, अगले चक्र के लिये तय किये जाने वाले प्रशुल्क में पूरा-पूरा समायोजित किया जाएगा। केओपीटी को 1 अप्रैल 2013 के बाद यदि कोई हानी पहुंची होगी तो वह निर्धारित किये जाने वाले प्रशुल्क में समायोजित नहीं की जाएगी।
