**Trade Circular**

**Sub: Policy for delivery of Direct Port Delivery (DPD) containers for 20 Top Volume Importers.**

Consequent to the nationwide Lockdown followed by different unseen reasons attributed to delayed clearance of DPD containers from Port, the competent authority has approved the following measure with immediate effect.

- 1) Top twenty (20) Volume Importers of KDS, SMP-Kolkata listed as DPD Clients can take direct delivery of containers from the docks up to six (6) days after Last date of Landing (LLD) beyond which their DPD status shall be withdrawn and the containers will be removed to the Shipping Line / Importer nominated CFS.
- 2) This policy shall remain in effect till 31.01.2021 and will be reviewed thereafter.


