Sub : Cashless referrals - Extension of additional medical benefits to the members of Existing "CPT Retired Employees (Contributory Outdoor and Indoor Medical Benefits) Scheme, 1997" on the occasion of Sesquicentenary Celebrations of KoPT.

This has reference to the following circulars/letters in connection with additional medical benefits to the members of "CPT Retired Employees (Contributory Outdoor and Indoor Medical Benefits) Scheme, 1997":-

- GAD's Circular No. Admn/3851/13/1/A dated 11.05.2020
- GAD's Circular No. Admn/3851/13/1/A dated 30.11.2022
- MS, HDC's circular No. MED/016/Cashless Treatment/885 dated 10.01.2023
- GAD's Circular No. Admn/3851/13/1/A dated 19.05.2023

2. Now, it has been decided that cashless facility for all the pensioners/family pensioners, who are/would be members of the "CPT Retired Employees (Contributory Outdoor and Indoor Medical Benefits) Scheme, 1997", would be implemented in the following way:-

- Patients, who will be referred for outdoor consultation & day-care services to the tie up centres, may avail of cashless facilities, only for those benefits which are available to the pensioners.
- The cashless facility may also be extended to the pensioners for the approved investigations in the list of extended medical benefits. The referrals would, however, be limited to the tie-up investigation centres which have agreed to provide cashless service.
- Indoor treatment at tie up centres on cash less basis is not possible at present due to technical difficulty in referral system. It is contemplated that once the new HMS module is successfully implemented by EBS ERP, the referral system will be integrated with the CGHS rate. Thereafter, cashless referral for the indoor services will also be introduced.

The cashless referral for OPD, day care & investigation services will be available with immediate effect.
