

- 1. That nothing has been shown in support of O.P's occupation into the public premises.
- 2. That no evidence has been laid to support the as O.P. lo. possession possession/occupation".
- 3. That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question.
- 4. That O.P has failed to hand over clear vacant and unencumbered possession of the subject quarter

ACCORDINGLY, Department is directed to draw up formal order of eviction u/s. 5 of the Act and Rules made thereunder against O.P., giving 15 days time to all to
