



The instant proceedings No. 1745/D of 2019 rises out of the application bearing No. nd.8/17/II/17/26 dated 2/03/2017 filed by the Kolkata Port Trust (KoPT), the applicant herein, praying for an order of recovery of dues and other charges etc. along with accrued interest in respect of the public premises as defined in the Schedule of said application, against M/S Kedarmull Keshardeo, the O.P herein, under relevant provisions of Public Premises (Eviction Inauthorized Occupants) Act, 1971.

The fact of the case in a nutshell is that the O.P. came into occupation of the port property being Godown space measuring 172.893sq.mt. or thereabout at Cossipore, Thana-Chitpur, District-Kolkata (under Plate Nos.CG-107) as long term lessee, more fully described in the 'Schedule of Property' of the KoPT's application. The allegations levelled by KoPT against the O.P is that while in possession of Port property as long term lessee, the O.P has defaulted in making payment of lamages/compensation and taxes and also accrued interest thereon the details of which has given in 'Schedule-B' of the KoPT's application.

t is the case of KoPT that the O.P. was asked to pay damages/compensation upto 07.01.1996 as because the subject premises was taken over by KoPT on 07.01.1996.

Considering the submission and documents as submitted by KoPT, Notice to Show Cause dated 30.07.2019(vide Order-04 dated 29.07.2019) was ssued by this forum to the O.P. U/s 7 of the ublic Premises (Eviction of Unauthorized Occupation) Act, 1971 to show cause as to why an rder requiring pay arrear lamages/compensation together with interest

After issuance of the aforesaid notice, on 30.07.2019 O.P. was not appeared before the Forum for giving reply to the Shaw Cause on 26.08.2019. However, the record depicts that such Notice had been sent to O.P both by hand and Registered Post as per addresses available on record and the communication sent through post has been returned back to the Forum with a report "Addressee moved ". However, the report of the Process Server depicts that such notice was not served upon O.P personally on 06.08.2019 as O.P was not found at the abovementioned addresses. As none appeared on behalf of O.P or any other person interested in the property, the attempts have been made by this Forum to provide chances to the O.P. for his appearance and filing of reply

before this Forum following the principles of natural justice. As none appeared on behalf of O.P in spite of repeated chances the matter was finally reserved on 09.09.2019 for passing final Order. Now this forum has decided to adjudicate the

As no one from O.P's side appears and no reply to the Show Cause Notice u/s 7 of the Act has been filed as yet, I have no bar to accept the claim of KoPT on account of damages/compensation etc. In fact, I have nothing to disbelief in respect of KoPT's claim against O.P. as per statement of accounts maintained regularly in KoPT's office in regular course of business.
