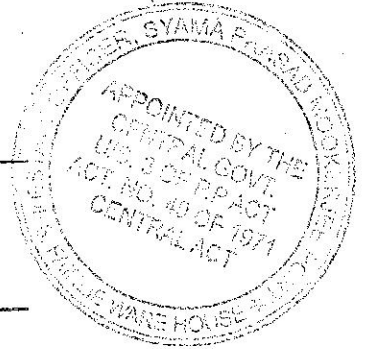

All concerned are directed to act accordingly.

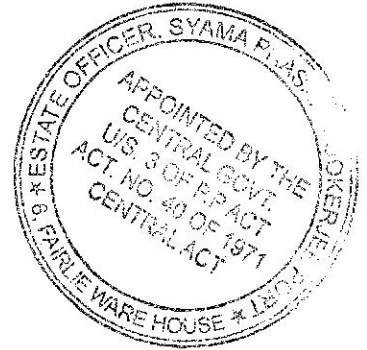

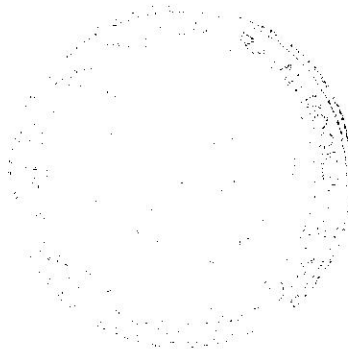
