

Whereas I, the undersigned, am satisfied that you were in unauthorised occupation of the public premises mentioned in the Schedule below:


And whereas by written notice dated 24.01.2019 you are called upon to show cause on/or before 21.02.2019 why an order requiring you to pay damages of Rs.33,65,326/- (Rupees Thirty Three Lakh Sixty Five thousand Three hundred Twenty six only) together with [compound interest] for unauthorised use and occupation of the said premises, should not be made;

And whereas I have considered your objections and/or the evidence produced by you.

Now, therefore, in exercise of the powers conferred on me by Sub-section (2) of Section 7 of the Public Premises (Eviction of Unauthorised Occupants) Act 1971, I hereby order you to pay the sum of Rs.33,65,326/- (Rupees Thirty Three Lakh Sixty Five thousand Three hundred Twenty six only) as damages on account of your unauthorised occupation of the premises for the period from 01.10.2012 to 28.12.2016 to SMP, Kolkata by 04.05.2021.

In exercise of the powers conferred by Sub-section (2A) of Section 7 of the said Act, I also hereby require you to pay compound interest @ 6.50 % per annum, which is the current rate of interest as per the Interest Act, 1978 (as gathered by me from the official website of the State Bank of India) from the date of incurrance of liability till its final payment in accordance with Kolkata Port Trust's Notification published in official Gazette/s.

In the event of your refusal or failure to pay the damages within the said period or in the manner aforesaid, the amount will be recovered as an arrear of land revenue through the Collector.

SCHEDULE

Land msg. about 1327.77 sq.m or thereabouts situated at Turner Road, Cossipore, Thana- Chitpore Police Station in the Presidency town of Kolkata (under **Plate No.SB-562**). It is bounded on the North partly by the Trustees' Turner Road and partly by the private property, on the East by the Trustees' Turner Road beyond which private property, On the South by the Trustees' land occupied by Prithibi Tewary and on the West by the Private property beyond which Chitpur Ghat Lane.
