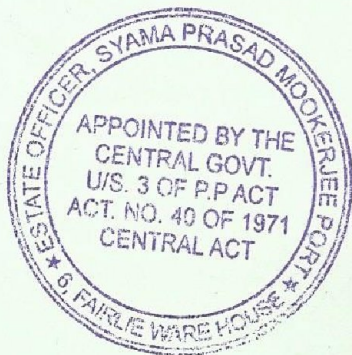

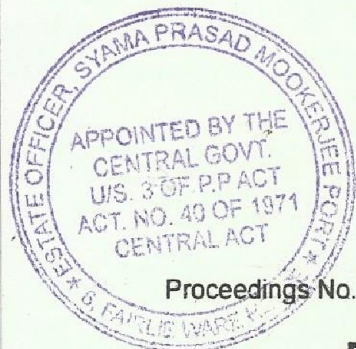

It is seen from the records that the Show Cause Notice dated 16.04.2021 passed under Section 4 and Sub-section (3) of Section 7 by this Forum was sent to O.P. through 'Speed Post' at the recorded address of O.P. but the same had not yet returned back prompting a good service and thereafter efforts were made by the Department to serve the said Show Cause Notice by the Department's Process Server but the Show Cause Notice could not be served upon O.P. due to the fact that O.P. had left the premises and the same is also evident from the Process Server's report of this Forum.

Through this Publication, O.P. is directed to appear before this Forum of Law on ^{08.07.2021} 17.06.2021 at 11:00 a.m. either in person or through authorised representative (alongwith an authorisation letter) and file written reply to the aforesaid Show Cause Notice in respect of the subject Public Premises, failing which the matter will be decided *ex-parte* without any further reference.

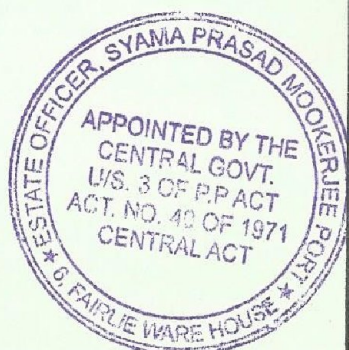
