
FITHE LD. ESTATE OFFICER ORDER UNDER SUB-SECTION (1) OF SECTION 5 OF THE PUBLIC RASAD MOOKERJEE PORT PREMISES (EVICTION OF UNAUTHORISED OCCUPANTS) ACT, 1971

> WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that Sri Prahalad Chandra Agarwala and Sri Umrao Prasad Agarwala, Jagannath Ghat, P-2, Strand Bank Road, Kolkata-700007 is in unauthorized occupation of the Public Premises specified in the Schedule below:

REASONS

- 1) That O.P. has violated the condition of such tenancy by way of remaining on possession of the subject premises after expiry of such long term lease on 28.02.2001.
- 2) That O.P or any other person interested in the property has failed to file any reply to the Show Cause Notice/s U/S 4 & 7 of the Act inspite of sufficient chances being provided to them.
- 3) That O.P has violated the condition of such tenancy by way of parting with possession of the subject premises to Morijwala Enterprise.
- 4) That the O.P has failed to bear any witness or adduce any evidence in support of their occupation as "authorised occupation".
- 5) That O.P has lost its authority to occupy the Public Premises after expiry of the period as mentioned in the Notice to Quit dated 30.03.2015.
- 6) That O.P's occupation has become unauthorised in view of Sec 2(g) of the Act and O.P is liable to pay damages for wrongful use and enjoyment of the Port property in question upto the date of handing over of clear, vacant and unencumbered possession to the Port Authority.

NOW, THEREFORE, in exercise of the powers conferred on me under Sub-Section (1) of Section 5 of the Public Premises (Eviction of Unauthorized Occupants) Act, 1971, I hereby order the said Sri Prahalad Chandra Agarwala and Sri Umrao Prasad Agarwala, Jagannath Ghat, P-2, Strand Bank Road, Kolkata-700007 and all persons who may be in occupation of the said premises or any part thereof to vacate the said premises within 15 days of the date of publication of this order. In the event of refusal or failure to comply with this order within the period specified above the said Sri Prahalad Chandra Agarwala and Sri Umrao Prasad Agarwala, Jagannath Ghat, P-2, Strand Bank Road, Kolkata-700007 and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

FINAL ORDER

The matter is taken up today for final disposal. It is the case of Syama Prasad Mookerjee Port, Kolkata [erstwhile Kolkata Port Trust], hereinafter referred to as SMP, Kolkata, Applicant herein, that a long term lease for a period of 10 years was granted to Sri Prahalad Chandra Agarwala and Sri Umrao Prasad Agarwala (O.P), on certain terms and conditions in respect of public premises being land msg. about 49.424 Sq.m situated at Jagannath Ghat, Thana- North Port Police Station, comprised under (Plate No.SB-46/1/1).

SMP, Kolkata has submitted that O.P violated the condition of such tenancy by way of remaining on the possession of the subject premises after expiry of such lease on 28.02.2001, by way of defaulting in payment of monthly compensation charges along with accrued interest thereon and also by way of parting with possession of the said premises to Morijwala Enterprise.

It is the case of SMP, Kolkata that in view of the aforesaid breaches committed by the O.P, SMP, Kolkata had issued notice to quit being No. Lnd. 5/90/II/15/3933 dated 30.03.2015 asking the O.P. to hand over clear, vacant, peaceful and unencumbered possession of the property to SMP, Kolkata on 30.04.2015. But O.P. has failed and neglected to vacate/ hand over the possession of such premises to SMP, Kolkata after service of the said Notice to Quit.

Now it is argued on behalf of SMP, Kolkata that O.P. has no authority under law to occupy the said public premises after expiry of the period as mentioned in the notice to quit dated 30.03.2015 and O.P is liable to pay damages for unauthorised enjoyment of the Port property in question.

This Forum formed its opinion to proceed against O.P under the relevant provisions of the Act and issued Show Cause Notice U/S 4 of the Act (for adjudication of the prayer for order of eviction etc.) and Show Cause Notice U/S-7(for adjudication of the prayer for recovery of arrear damages etc.) both dated 09.12.2020 (vide Order No. 12 dated 09.12.2020 as per rule made under the Act.

On the scheduled date of appearance and filing of reply to the Show Cause i.e on 23.12.2020 O.P. did not appear before the Forum for giving reply to the Shaw Cause. However, the record depicts that such Notice had been sent to O.P both by hand and Speed Post as per addresses available on record.

When the Postal Services to the recorded addresses of O.P returned undelivered with the endorsement of Postal Department as "insufficient address" and the Process Server has also failed to locate the address of O.P(as per their Report dated 17.02.2021), the Forum vide its order dated 23.12.2020 gave a direction to SMP, Kolkata for filing other alternative addresses of O.P. However, SMP, Kolkata has failed to file such alternative addresses of O.P.

It appears that in spite of such efforts being made, the appearance of O.P could not be procured in order to contest the claim of SMP, Kolkata by usual course of business followed by this Forum and such efforts remain futile. Accordingly a decision was taken to publish a Notice in a widely circulated News Paper for a notice to all concerned about the pendency of the instant proceeding in order to give further chance to O.P to appear before the Forum and to represent their case. Such Notice was published in the classified column of Times of India (Kolkata) on 09.04.2021 fixing the ultimate date of O.P's appearance on 28.04.2021. But all the efforts went into vain as the O.P failed to appear before the Forum despite publication of such Notice in the News Paper.

Now in view of the spirit laid down in the Public Premises Act, 1971 for speedy and summary disposal of the case and further considering the continuous non appearance of O.P in spite of sufficient opportunities being given and after exhaustion of all available means of service, this Forum finds no need to keep the matter pending and final Order was reserved in the matter on 28.04.2021. Now this Forum has decided to adjudicate the matter exparte.

As no one from O.P's side appears and no reply to the Show Cause Notice u/s 4 & 7 of the Act has been filed as yet, I have no bar to accept the claim of SMP, Kolkata on account of unauthorised occupation of O.P into the

Public Premises in question. I think that it is a fit case for issuing Order of eviction u/s 5 of the Act on the following grounds:-

- 1) That O.P. has violated the condition of such tenancy by way of remaining on possession of the subject premises after expiry of such long term lease on 28.02.2001.
- 2) That O.P or any other person interested in the property has failed to file any reply to the Show Cause Notice/s U/S 4 & 7 of the Act inspite of sufficient chances being provided to them.
- 3) That O.P has violated the condition of such tenancy by way of parting with possession of the subject premises to Morijwala Enterprise.
- 4) That the O.P has failed to bear any witness or adduce any evidence in support of their occupation as "authorised occupation".
- 5) That O.P has lost its authority to occupy the Public Premises after expiry of the period as mentioned in the Notice to Quit dated 30.03.2015.
- 6) That O.P's occupation has become unauthorised in view of Sec 2(g) of the Act and O.P is liable to pay damages for wrongful use and enjoyment of the Port property in question upto the date of handing over of clear, vacant and unencumbered possession to the Port Authority.

ACCORDINGLY, Department is directed to draw up formal order of eviction u/s.5 of the Act as per Rule made there under, giving 15 days time to O.Ps' and any person/s whoever may be in occupation to vacate the premises. I make it clear that all person/s whoever may be in occupation are liable to be evicted by this order and the Port Authority is entitled to claim damages for unauthorized use and enjoyment of the property against O.Ps' in accordance with Law up to the date of recovery of possession of the same.

It is my considered view that a sum of Rs. 21,61,636.80 (Rupees Twenty One Lakhs Sixty One Thousand Six Hundred Thirty Six and paisa Eighty only) for the respective Plate in question for the period March, 2001 to July, 2020 (both days inclusive) is due and recoverable

from O.P. by the Port authority on account of damages and O.P. must have to pay such dues to SMP, Kolkata on or before 25:10:202|Such dues attract compound interest @ 6.20 % per annum, which is the current rate of interest as per the Interest Act, 1978 (as gathered by me from the official website of the State Bank of India) from the date of incurrence of liability, till the liquidation of the same, as per the adjustment of payments, if any made so far by O.P., in terms of SMP, Kolkata's books of accounts.

I make it clear that SMP, Kolkata is entitled to claim further damages against O.P. for unauthorized use and occupation of the public premises right upto the date of recovery of clear, vacant and unencumbered possession of the same in accordance with Law, and as such the liability of O.P. to pay damages extends beyond July, 2020 as well, till such time the possession of the premises continues to be under the unauthorized occupation with the O.P. SMP, Kolkata is directed to submit a statement comprising details of its calculation of damages after July, 2020, indicating there-in, the details of the rate of such charges, and the period of the damages (i.e. till the date of taking over of possession) together with the basis on which such charges are claimed against O.P., for my consideration for the purpose of assessment of such damages as per Rule made under the Act.

I make it clear that in the event of failure on the part of O.P. to comply with this Order, Port Authority is entitled to proceed further for execution of this order in accordance with law. All concerned are directed to act accordingly.
