

FINAL ORDER

The matter is taken up today for delivering Final Order. It is the case of Syama Prasad Mookerjee Port, Kolkata (Erstwhile Kolkata Port Trust/KoPT), hereinafter referred to as 'SMPK', the Applicant herein, that M/s. B.B Paul & Company (O.P) came into occupation of the Public Premises in question being land msg. about 134.12 Sq.m situated at Cross Road No.8, Kulpighat, comprised under occupation/Plate No. SB-126/2 as a long term lessee for a period of 10 years w.e.f 10.09.1988 and such lease in respect of the land in question was expired on 09.09.1998 due to efflux of time.
