Sub: Filling up the post of Chief Medical
Officer in Kolkata Port Trust.

Sir,

The post of Chief Medical Officer in the scale of pay of Rs. 51,300-73, 000/- in the rank of Head of Department will fall vacant w.e.f. 1st April, 2015.

As per revised Recruitment Rule the post is to be filled up by absorption through composite method from Major Ports.

For absorption through composite method, officers holding analogous posts or officers holding post of Chief Medical Officer in category-II ports with 2 years regular service in the grade or officers holding posts in the scale of pay of Rs. 36,600-62,000/- with 4 years regular service in the grade or officers holding posts in the scale of pay of Rs. 32,900-58,000/- with 5 years regular service in the grade in the Medical Department in a Major Port Trust will be eligible.

The selection is by merit for which the overall grading in the confidential reports shall be "Very Good."

2. Names of suitable and willing officers, who satisfy the provisions of the Recruitment Rules (Annexure – I) for the post of Chief Medical Officer, may please be furnished together with their application as per proforma enclosed (Annexure-II) along with the following documents so as to reach the undersigned on or before 22nd December, 2014:-

- iii) No objection certificate of respective Port.
- iv) Undertaking of the applicant not to withdraw, if selected.
- v) Vigilance/Administrative Clearance of the concerned Port (Annexure-III).
- vi) Two passport size photographs.
