Sub:- Filling up of the post of Harbour Master (River) by absorption through composite method at SMP, Kolkata – applications invited.

One post of Harbour Master (River) in the scale of pay of Rs.1,00,000-2,60,000/- under SMP, Kolkata will fall vacant w.e.f. 01.01.2021, which is to be filled up by absorption through composite method.

2. Applications are invited for filling up of the above post of Harbour Master (River) from amongst the officers of Major Port Trust holding analogous post or the post of Dy. Harbour Master (Port)/(River) and equivalent post with 3 years regular service in the grade.

3. The selection is by merit for which overall grading in the ACRs/APARs will not be below “Very Good”

4. - iii) No objection certificate from the respective Port.
- iv) Undertaking of the applicant to the effect that the candidature will not be withdrawn, if selected.

- v) Vigilance and administrative clearance by the concerned Port (**Annexure-III**)
- vi) Passport size photographs (two numbers).
5. The Crucial date for determining the eligibility will be the date of occurrence of vacancy i.e. **01.01.2021** in terms of Ministry of Shipping Circular No.1-26/25/2013-PE-I dated 26.9.2019.
