NOTICE

Sub: Opening bank account for operation of Pension/ family pension on any Nationalized banks or RBI guided Private banks throughout India for LIC bound pensioners/ family pensioners of KDS.

Ref: This office Notice bearing No. Fin/PSLI/10/1523 dated 8/10. 02.2010 & No. Fin/PSLI/H/324 dated 26.05.2015.

As you are aware, pensioners and family pensioners are entitled to open Bank Accounts for their disbursements at State Bank of India (all over India) and at Indian Overseas Bank, Canara Bank, UCO Bank and United Bank of India presently merged with Punjab National Bank (for State of West Bengal.).

In view of the representation received from Unions, the competent authority has decided to allow all Nationalised Banks for those pensioners whose pension is being disbursed by Life Insurance Corporation of India.

The pensioners including family pensioners whose pension is being disbursed by Port will continue to receive pension through existing five Banks as per present practice.

A format for new bank option form is placed as **Annexure -' B'** and existing old Bank option form is also attached as **Annexure - 'A'** for information of the pensioners and family pensioners of KDS.
