
**Subject: Extension of time period of submission of Life Certificates of pensioners and family pensioners of KDS, SMP, Kolkata (erstwhile KoPT) to the Bank till February, 2022.**

Kindly refer to this office earlier letter No.FIN/PSLI/21/1349 dated November 17, 2021.

In this connection it may kindly be noted that Competent Authority of SMPK (erstwhile KoPT) has decided to continue pension to the pensioners till February, 2022 for those who have submitted their Life Certificates on and from 01.09.2021

to 28.02.2022 either in hard copy or through Jeevan Pramaan Portal under Syama Prasad Mookerjee Port, Kolkata. This office will provide a list of DLC (Digital Life Certificate) received through Jeevan Pramaan Portal to your bank from time to time for continuation of their pension without any interruption.

It is requested that for the current year 2021-22, a copy of Life Certificate collected from the pensioners / family pensioners from September '21 to February, 22 (i.e. 01.09.21 to 28.02.2022) should be forwarded to this office by 10<sup>th</sup> March, 2022 positively (with a consolidated statement in an excel format) and also the pension payment must be stopped from March 2022, if Life Certificate is not furnished by any pensioner / family pensioner within 28.02.2022.
