WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that Smt. Gyanti Devi and her family members, Quarters No.35 & 36, Block No. G, Taratala New Colony Mazdoor Line, P.S: Taratala, Kolkata-700088 is in unauthorized occupation of the Public Premises specified in the Schedule below:

## REASONS

- 1) That no reply to the Show Cause notice is filed by O.P.
- 2) That nothing has been shown in support of O.P"s occupation into the public premises.
- 3) That no evidence has been laid to support the possession of O.P. as "authorized possession/ occupation".
- 4) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question.
- 5) That O.Ps occupation is unauthorized in all respect and O.P has failed to make out any case in support of his occupation.

In the event of refusal or failure to comply with this order within the period specified above the said Smt. Gyanti Devi and her family members, Quarters No.35 & 36, Block No. G, Taratala New Colony Mazdoor Line, P.S: Taratala, Kolkata-700088 and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

## FINAL ORDER

The matter is taken up today for final disposal. It is the case of Syama Prasad Mookerjee Port, Kolkata [erstwhile Kolkata Port Trust], hereinafter referred to as SMP, Kolkata, Applicant herein, that Quarters No.35 & 36, Block No. G at Taratala New Colony Mazdoor Line, P.S. Taratala, Kolkata-700088 is under the occupation of Smt. Gyanti Devi and her Family members (herein after referred to as O.P.). It is further submitted by SMP, Kolkata that such quarters were originally allotted to Shri Ram Karut Ahir on 24.04.2015 who was an employee of the Traffic Department of SMP, Kolkata and said allottee died on 10.04.2019 and after his demise, such allotment was cancelled, on and from 10.04.2019, as per Rule Rules Governing the of 5(ii)/5(iii) Commissioners Residential Accommodation for Class-IV employees. However, Gyanti Devi (wife of Ram Karut Ahir) and her family members are still under occupation of the said quarters in violation of the above mentioned Rule. Now SMP, Kolkata has argued that O.P and her family members have no authority to occupy such quarters after cancellation of allotment and thus the occupation of O.P and her family members in the quarters in question are unauthorized.

This Forum formed its opinion to proceed against O.P under the relevant provisions of the Act and issued Show Cause Notice U/S 4 of the Act (for adjudication of the prayer for order of eviction)

It is seen from the record that in the course of hearing neither the O.P. is any person interested in the subject premises have appeared before the Forum. No reply to the Show Cause Notice has also been filed by the O.P or any person interested in the property. In view of the above, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have nothing to disbelieve the statement made against O.P by the Port Authority. Accordingly the order of eviction issued on the following grounds/reasons:

- 1) That no reply to the Show Cause notice is filed by O.P.
- 2) That nothing has been shown in support of O.P"s occupation into the public premises.
- 3) That no evidence has been laid to support the possession of O.P. as "authorized possession/ occupation".
