The matter is taken up today for final disposal. It is the case of Syama Prasad Mookerjee Port, Kolkata [erstwhile Kolkata Port Trust], hereinafter referred to as SMP, Kolkata, Applicant herein, that Quarter No.3, Block No. C at K.F. Shipping, P.S. South Port Police Station, Kolkata-700023 was under the lock and key of SMP, Kolkata since 19.10.1995. However, one Sri Raj Mahammad (hereinafter referred to as O.P. No. 1), rank outsider forcibly occupied said Quarter by breaking open SMPK's padlock on or about 01.07.1999 and since then the O.P. No 1 was living unauthorisedly in the said quarter/ public premises as an unauthorised occupant. It is further the case of SMPK that on a recent inspection it has been found that the said quarter is presently being unauthorisedly occupied by one Sri Munna (hereinafter referred to as O.P. No. 2), who is also a rank outsider into the quarter/public premises in question.

This Forum formed its opinion to proceed against both O.P. No 1 and 2 by issuing the Show Cause Notice dated 22.02.2021 (vide Order no 04 dated 22.02.2021) for adjudication of the prayer of eviction, under the relevant provisions of Public Premises (Eviction of Unauthorized Occupants) Act, 1971 (hereinafter referred to as 'the Act') and the Rules made thereunder. The O.P. no 1 & 2 were called upon as per the relevant provisions of the Act and the Rules made thereunder to appear before this forum in person or through authorized representative/s, capable to answer all material questions connected with the matter, along with the evidence which the O.P.s intends to produce in support of their case.

The said Notice was sent through 'Speed Post'/hand delivery to the Quarter address of the O.P. The notice

addressed to O.P No.2 returned undelivered to the Forum due to possible insufficient address of O.P. however, the communication sent to O.P No.1 was not returned back to the Forum. The 'Process Server' attached with this Forum has submitted his report dated 03.02.2021 intimating that the parties did not allow him to enter into the premises and threatened to assault him in case he makes further attempt to visit there. However, considering O.P. refusal, a further attempt was made to serve such notice upon Opposite Parties in terms of Order dated 29.06.2021. It appears from the report of 'Process Server' dated 26.07.2021 that such Order was affixed on the subject quarter in question as per the mandate of the P.P Act. However, inspite of such efforts, nobody appeared before me with any authority to stay into the quarters in question. Considered the report of the Process Server dated 24.03.2021 and 26.07.2021 regarding affixation of Show Cause Notice u/s 4 of the Act on the property in question. I am satisfied with the service of notice to all concerned. No reply to the Show Cause Notice u/s 4 of the Act dated 22.02.2021 on behalf of either O.P. no 1 or O.P. no 2 has been filed yet. As such, I have nothing to disbelieve the statements made against both the O.P.s by the Port Authority. In fact, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority on the following grounds/reasons.

- 4. That both the O.P's occupation is unauthorized in all respect and both the O.P's have failed to make out any case in support of their occupation.
