The matter is taken up for hearing today. None appears on behalf of O.P. to file reply to the Show Cause Notice dated 23.03.2022. It is seen from the records that the Show Cause Notice dated 23.03.2022 passed under Section 7 by this Forum was sent to O.P. through 'Speed Post' at the recorded addresses of O.P. and the same had returned back. The Show Cause Notice was also sent by hand delivery through the Department's Process Server and it was duly received by one Saidha Parvin on 29.03.2022. However another chance was given to O.P. to represent the case before this Forum. Thereafter subsequent orders were sent to O.P. through 'Speed Post' and the same had returned back on 27.05.2022. The subsequent order was also sent by hand delivery through the Department's Process Server, which were refused by O.P. and then the same was affixed at a conspicuous part of the addresses of O.P. and the same is evident from the Process Server's report of this Forum.

In view of the circumstances, Department is directed to publish a Notice in classified column of an English Daily News Paper having wide circulation as well as in the Website of Syama Prasad Mookerjee Port, Kolkata at the earliest for information of the O.P. and/or any person interested in the subject Public Premises regarding the pendency of the present proceeding.

Through this Publication, O.P. is directed to appear before this Forum of Law on 28.7.2022 at 11 AM. either in person or through authorised representative (alongwith an authorisation letter) and file written reply to the aforesaid Show Cause Notice in respect of the subject Public Premises, failing which the matter shall be decided *ex-parte* without any further reference.

Let the matter come up for hearing, submission, production of documents, consideration etc. on 28.7.2022 at 11 A.M. All concerned are directed to act accordingly.
