Whereas, Proceedings against M/s Radha Krishna Gopi Krishna, the O.P. herein, have been initiated u/s 4 & 7 of the P.P. Act for adjudication of the prayer of Kolkata Port Trust (KoPT) for order of eviction in respect of Kolkata Port Trust's plot being land measuring 203.985 sq.m. (Plate No. SB- 234) situated on the North side of Jorabagan Cross Road at Nimtillah morefully described under the schedule.

AND WHEREAS, Service to M/s Radha Krishna Gopi Krishna, the O.P. herein was effected trough affixation upon the subject premises on 05.03.2019.

AND WHEREAS, O.P. failed to appear before this Forum on the last two occasions on 18.03.19 and 01.04.19.

AND WHEREAS, no reply to the show cause notice has been filed as yet.

NOW THEREFORE, in exercise of the power conferred upon me, I hereby give notice to all concerned interested in the property under schedule to file reply to the Show Cause Notice on or before 13.06.2019 and to appear before me on 13.06.2019 at 10.30 A.M. either in person or through authorised representative (along with a letter of authority) capable of answering all material questions in



respect of the property described under the Schedule below, failing which the matter will be decided exparte without any further reference.

SCHEDULE (SB 234)

Land measuring 203.985 sq. m on the North side of Jorabagan Cross Road at Nimtollah, Thana: Jorabagan Police Station, in the Presidency town of Kolkata, under Plate No. SB 234. It is bounded on the North by Trustees' land occupied by Iswar Prosad Singh, on the East by Trustees' land occupied by Hare Krissan Singh, on the South by Jorabagan Cross Road and on the West by Trustees' land occupied by Laxmi Kanta Kashiram.
