COVID 19 Vaccination Drive

The COVID 19 Vaccination drive started at SMP, Kolkata on 27.1.2021 with the first dose being given to Dr. Tapan Hajra, MS, Port Hospital, HDC of SMP, Kolkata.





Asset Monetization Drive

On 30.1.2021, SMP, Kolkata received the first ever domestic auto rake from Trac1 Logistics at GCD yard siding. This will yield additional returns to the port from underutilised rail siding & provide a reliable terminal facility to auto rake operators.





II. <u>CARGO THROUGHPUT</u> :

- SMP, Kolkata handled 49.446 million tonnes (mt) of traffic during April 2020- January 2021 vis-à-vis 52.878 mt during April 2019- January 2020, registering a fall of 6.49% due to serial Lockdowns of varying intensities, continuing in the aftermath of the outbreak of Pandemic COVID 19. Significantly, the fall in traffic (overall at SMP, Kolkata) which was around 23.74% till August'2020, has gradually narrowed down to 14.08% till October'2020 and further to 6.49% till January 2021, primarily due to robust traffic growth experienced by HDC during the intervening months. Iron Ore, Manganese Ore, Iron & Steel Products, POL (Crude), LPG, Finished Fertiliser, etc. through HDC and Other Coal / Coke and Pulses through KDS have been showing an increasing trend during April 2020- January 2021.
- HDC handled 37.148 mt of cargo in April 2020- January 2021 vis-à-vis 38.392 mt in April 2019- January 2020 (3.24% decrease). KDS handled 12.298 mt of cargo in April 2020- January 2021 vis-à-vis 14.486 mt in April 2019- January 2020 (15.10% decrease).

III. <u>CONTAINER TRAFFIC</u> :

SMP, Kolkata handled 5,62,488 TEUs (KDS: 4,44,831 & HDC: 1,17,657) during April 2020- January 2021 vis-à-vis 7,23,157 TEUs (KDS: 5,78,146 & HDC: 1,45,011) during April 2019- January 2020, recording a fall of 22.22%.

IV. <u>SHIP TRAFFIC</u> :

During April 2020- January 2021, 2623 ships (KDS: 857, HDC: 1766) called at SMP, Kolkata. 3529 vessels (1766 inward; 1763 outward) passed through Eden channel in April 2020- January 2021 to / from Haldia.

V. <u>RAILWAY TRAFFIC</u> :

During April 2020- January 2021, SMP, Kolkata handled rail-borne traffic of 22.92 mt (KDS-3.87 mt & HDC-19.05 mt) against 24.06 mt (KDS-4.06 mt & HDC-20.00 mt) in April 2019- January 2020 registering a fall of 4.74%. During April 2020- January 2021, 910 trains were received and 925 despatched at KDS; at HDC, 3821 trains were received and 3807 were despatched.
