I. NOTABLE ACHIEVEMENTS / DEVELOPMENTS

Visit of Hon'ble Union Minister of State at SMPK

II. <u>CARGO THROUGHPUT</u>:

- > SMP, Kolkata handled 27.245 million tonnes (mt) of cargo during April- September 2021, vis-à-vis 25.847 mt during April- September 2020, registering a growth of 5.41%.
- ➤ HDC handled 20.262 mt of cargo during April- September 2021 vis-à-vis 19.386 mt during April-September 2020 (recording a growth of 4.52%). KDS handled 6.983 mt of cargo in April-September 2021 vis-à-vis 6.461 mt during April- September 2021 (recording a growth of 8.08%).
- ➤ HDC registered growth in respect of POL(Product), Vegetable Oil, Other Liquid, LPG, Coking Coal, Limestone, Fertiliser & its raw materials, Manganese Ore, Container, etc. while KDS registered growth in respect of Vegetable Oil, FRM, Coking Coal, Fly Ash and Container.

III. <u>CONTAINER TRAFFIC</u>:

- ➤ SMP, Kolkata handled 3,80,574 TEUs (KDS: 2,89,746 & HDC: 90,828) during April- September 2021 vis-à-vis 3,17,382 TEUs (KDS: 2,50,239 & HDC: 67,143) during April- September 2020, registering a high growth of 19.91%.
- ➤ While HDC recorded a steep growth of 35.28%, KDS too registered a satisfactory growth of 15.79%, during April September 2021 vis-à-vis April September 2020, in handling of Containers (TEUs).

IV. COMPARATIVE PERFORMANCE

SMP, Kolkata ranked 2nd in handling of both Coking/Other Coal and Other Liquids among the Indian Major Ports during April - September 2021.

V. <u>SHIP TRAFFIC</u>:

During April- September 2021, 1453 ships (KDS: 482, HDC: 971) called at SMP, Kolkata vis-a-vis 1456 ships (KDS: 480, HDC: 976) during April-September 2020. 1945 vessels (971 inward; 974 outward) passed through Eden Channel during April - September 2021 to / from Haldia.

V <u>RAILWAY TRAFFIC</u>:

During April-September 2021, SMP, Kolkata handled rail-borne traffic of 14.505 mt (KDS-2.668 mt & HDC- 11.837 mt) against 13.051 mt (KDS-2.244 mt & HDC-10.807 mt) in April- September 2020 registering a growth of 11.14%. During April - September 2021, 681 trains were received and 688 despatched at KDS; at HDC, 2629 trains were received and 2058 were dispatched.
