The O.P. in violation of the tenancy agreement failed and neglected to pay the rent and taxes to SMPK for the said leased out premises. The Authorised Officer was appointed to take over possession of the premises in terms of the Order dated 26.04.2016 and finally, the possession of the premises was taken over on 08.08.2016 by the Authorised Officer, who handed it over to SMPK.

Now, SMPK in terms of the said application dated 12.02.2018 and vide the following application dated 16.03.2020, has submitted its claim on account of compensation/ damage/ mesne profit charges, which reportedly was due and recoverable from O.P. for its use and enjoyment of the port property in question. After considering the claim of SMPK, this Forum formed its opinion to proceed against the O.P. and issued Show

Cause Notice dated 17.08.2020 (vide Order no. 02 dated 17.08.2020) u/s 7 of the Public Premises (Eviction of Unauthorized Occupation) Act, 1971. The Notice was issued calling upon the O.P. to show cause as to why an order requiring payment of arrear compensation/ damage together with interest would not be made against the O.P.

The said Notice was sent through 'Speed Post' to 4 (four) no of recorded addresses of O.P. However, the notice was returned undelivered by the Postal Department from all the recorded addresses of O.P. with the remarks 'No such addressee in Beat No 1. hence, not known' and 'ACNL, RTS'. The 'Process Server' attached with this Forum for service of such Notices/ Orders etc. has submitted the Report dated 08.01.2021, stating that the door of the occupation of O.P. was in closed condition at the time of his visit on 08.01.2021. However, in terms of the said Report of Process Server dated 08.01.2021, the said notice was affixed on the premises, as per the mandate of the Act. Inspite of such efforts being made, the appearance of O.P. could not be procured and such efforts remained futile. Then the possibility of O.P. having an alternative address was explored by this Forum and SMPK was directed vide Order dated 09.10.2020 to provide the alternative address of O.P., if any. In response, the representative of SMPK submitted on 25.04.2022, that they have no alternative address of O.P. other than the recorded addresses as aforesaid. Accordingly, a decision was taken vide Order dated 25.04.2022 to publish a notice in a widely circulated newspaper for a notice to all concerned about the pendency of the instant proceeding in order to give a chance to the O.P. to appear before this Forum and to represent their case. Such notice was published in 'The Times of India (Kolkata edition)' on 07.05.2022 fixing the date for the O.P's appearance, filing reply to Show Cause on 16.05.2022. However, when the matter was taken up for hearing on 16.05.2022, neither O.P. nor anyone interested in the property appeared before the Forum. It was also known from Department that nobody, except
