The matter is taken up today for delivering the final order. It is the case of Syama Prasad Mookerjee Port, Kolkata [earstwhile Kolkata Port Trust/ KoPT (hereinafter referred to as 'SMPK'/ Port Authority'), applicant herein, that Quarter no 3 & 4, Block No N at Taratala New Colony Mazdoor Line, P.S. Taratala, Kolkata- 700 088 were allotted to Krishna Chandra Bej (since deceased), who had been employed with the Officers' Club, SMPK and during the tenure of his employment approached SMPK authorities for allotment of a residential quarter in his favour. It is SYAMA PRASAD MOOKERJEE PORT

submitted by SMPK that the said quarters were allotted in his favour on 15.06.2009. It is further submitted by SMPK that said Krishna Chandra Bej has expired on 30.11.2016 and as per Rule 5(ii)/5(iii) of the Rules Governing the Commissioners Residential Accommodation for Class-IV employees, the allotment of the quarters stood cancelled. It is further the case of SMPK that subsequently, the heir/s of said Krishna Chandra Bej (since deceased) did not vacate the said quarters and holding the same unauthorisedly and as such, the same could not be allotted to any employee of SMPK, who would be in need of such residential quarters. It is further the case of SMPK that after the demise of Krishna Chandra Bej, the quarters is under unauthorised occupation of heir/s of said Kiishna Chandra Bej (since deceased).

This Forum formed its opinion to proceed against the O.P. and issued the Show Cause Notice dated 07.04.2022 (vide Order no 01 dated 06.04.2022) for adjudication of the prayer of eviction, under the relevant provisions of Public Premises (Eviction of Unauthorized Occupants) Act, 1971 (hereinafter referred to as 'the Act') and the Rules made thereunder. The addressee was called upon as per the relevant provisions of the Act and the Rules made thereunder to appear before this Forum in person or through authorized representative/s, capable to answer all material questions connected with the matter, along with the

evidence which the O.P.s intends to produce in support of their case.

The said Notice dated 07.04.2022 has been affixed on the property in question, as per the mandate of the Act, as it appears from the Report of Process Server' dated 13.04.2022. The Process Server' Report also indicates that hand service of the notice has been effected upon one Shri Suraj Kr. Pandey, who received the same under acknowledgement on 13.04.2022. However, on the day fixed for show cause, the matter could not be taken up for hearing due to sudden engagement with other urgent official works. The matter, thereafter, was taken up for hearing on SYAMA PRASAD MOOKERJEE PORT 11.05.2022, when one Shri Dipak Kumar Bej (Pandey), representing himself as the son of O.P., appeared before the Forum and expressed willingness for surrender of the quarters. He filed an application dated 11.05.2022 in confirmation of his willingness to surrender the quarters. He, however, stated that the electricity connection could not be disconnected from CESC, as the electric meter is not in his deceased father's name. Considering the situation, said Shri Dipak Kumar Bej (Pandey) was directed to vacate the premises and file a Report with the Forum by the next date of hearing i.e. 08.06.2022. Additionally, SMPK was directed to intimate the status to this Forum. Be it mentioned here that Shri Dipak Kumar Bej (Pandey)/ O.P. has chosen not to deal with or contradict any issue indicated in the Notice to Show Cause issued by this Forum.

Considered the report of the Process Server dated 13.04.2022. I am satisfied with the service of notice to all concerned as affixation of Show Cause Notice was made on the property in question. It emerges that nobody appeared before me till date with any authority to stay into the quarters in question. It appears that no reply to the Show Cause Notice u/s 4 of the Act dated 07.04.2022 on behalf of any person was filed. As such, I have nothing to disbelieve the statements made by the Port Authority. In fact, I am left with no other alternative but to issue order of
