ORDER UNDER SUB-SECTION (1) OF SECTION 5 OF THE PUBLIC PREMISES (EVICTION OF UNAUTHORISED OCCUPANTS) ACT, 1971

WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that Shri Kishore, residing at Quarters No 4, Block No.3, Hide Road Mazdoor Line, P.S.: South Port Police Station, Kolkata-700043 is in unauthorized occupation of the Public Premises specified in the Schedule below:

#### REASONS

- 1) That no reply to the Show Cause notice is filed by O.P.
- 2) That nothing has been shown in support of O.P"s occupation into the public premises.
- 3) That no evidence has been laid to support the possession of O.P. as "authorized possession/ occupation".
- 4) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question.
- That O.P's occupation is unauthorized in all respect and O.P has failed to make out any case in support of his occupation.

NOW, THEREFORE, in exercise of the powers conferred on me under Sub-Section (1) of Section 5 of the Public Premises (Eviction of Unauthorized Occupants) Act, 1971, I hereby order the said Shri Kishore, residing at Quarters No 4, Block No.3, Hide Road Mazdoor Line, P.S.: South Port Police Station, Kolkata-700043 and all persons who may be in occupation of the said premises or any part thereof to vacate the said premises within 15 days of the date of publication of this order. In the event of refusal or failure to comply with this order within the period specified above the said Shri Kishore, residing at Quarters No 4, Block No.3, Hide Road Mazdoor Line, P.S.: South Port Police Station, Kolkata-700043 and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

### FINAL ORDER

The matter is taken up today for final disposal. It is the case of Syama Prasad Mookerjee Port, Kolkata [erstwhile Kolkata Port Trust], hereinafter referred to as SMPK, Applicant herein, that Quarters No.4, Block No. 3 at Hide Road Mazdoor Line, P.S. South Port Police Station, Kolkata-700043 was under the lock and key of SMPK since 09.11.2000. However, one Shri Kishore(O.P.) herein, forcibly occupied said Quarter by breaking open SMPK's padlock on or about 06.12.2000 and since then the O.P. was living unauthorisedly in the said quarter/ public premises as an unauthorised occupant. It is further the case of SMPK that on a recent inspection it has been found that the said quarter is presently being unauthorisedly occupied by one Shri Paresh Nath Yadav, who is a rank outsider into the quarter/public premises in

This Forum formed its opinion to proceed against O.P under the relevant provisions of the Act and issued Show Cause Notice U/S 4 of the Act (for adjudication of the prayer for order of eviction) dated 09.05.2022 (vide Order No.4 dated 21.04.2022) as per rule made under the Act and such Show Cause notice was sent to O.P both by hand and Speed Post as per address available on record. The Postal Service to the recorded address of O.P. returned undelivered to the Forum with a remark "addressee Moved". The report of the Process Server dated 12.05.2022 also reveals that such Notice was neither served upon the O.P. nor affixed on the subject quarter in question due to O.P's resistance.

On the Schedule date of appearance and filing of reply to the Show Cause although no hearing was held due to official engagement of the Estate Officer, however, it appears from the record that on the subsequent date of hearing i.e on 09.06.2022 one Aishwarya Rajyashree, expressing herself as a Ld' Advocate of O.P., appeared before the Forum and prayed time to file her vakalatnama as well as reply to the Show Cause to contest the instant matter. It also appears that except 09.06.2022, the said Advocate of O.P. or any other person interested in the quarter in question,

was never appeared before the Forum to counter the allegation of SMPK. No reply to the Show Cause Notice has also been filed by the O.P or any person interested in the property as yet. In view of the above, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have nothing to disbelieve the statement made against O.P by the Port Authority. Accordingly the order of eviction issued on the following grounds/reasons:

- 1) That no reply to the Show Cause notice is filed by O.P.
- 2) That nothing has been shown in support of O.P"s occupation into the public premises.
- 3) That no evidence has been laid to support the possession of O.P. as "authorized possession/ occupation".
- 4) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question.
- 5) That O.Ps occupation is unauthorized in all respect and O.P has failed to make out any case in support of his occupation.

ACCORDINGLY, Department is directed to draw up formal order of eviction u/s 5 of the Act and Rules made thereunder against O.P, giving 15 days time to all to vacate the public premises. I make it clear that all the occupants of the quarters in question whoever may be in occupation are liable to be evicted by this order and SMPK is entitled to claim damages for unauthorised use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.
